#### ORDINANCE NO. 0-88-09

#### AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF DELANO TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND OWNED BY THE CITY OF DELANO AND ABUTTING UPON CITY LIMITS

WHEREAS, by deed dated the 14th day of October, 1987 the County of Wright conveyed and quit claimed to the City of Delano certain real property situated in the County of Wright described as follows:

The Southeast Quarter of Southeast Quarter (SE<sup>1</sup>/<sub>4</sub> of SE<sup>1</sup>/<sub>4</sub>) of Section 2, Township 118 Range 25; the East 24 acres of Southwest Quarter of the Southeast Quarter (SW<sup>1</sup>/<sub>4</sub> of SE<sup>1</sup>/<sub>4</sub>) of Section 2, Township 118, Range 25; Lots 6 and 7 in West Half of Northeast Quarter (W<sup>1</sup>/<sub>2</sub> of NE<sup>1</sup>/<sub>4</sub>) of Section 11, Township 118, Range 25, according to the recorded plat thereof.

WHEREAS, said property abutts the City limits of the City of Delano:

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF DELANO, MINNESOTA ORDAINS:

<u>Section 1</u>. The City Council hereby determines that the territory described herein abutts upon the City limits, is owned by the City of Delano and that none of the territory is now included within the limits of any city.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described above and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof. Page -2-

Section 3. Filing. The City Clerk is directed to file certified copies of this Ordinance with the Minnesota Municipal Board, Franklin Township, the Wright County Auditor, and the Secretary of State.

Section 4. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3 and approval of the Ordinance by the Minnesota Municipal Board.
