



ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Gaylord and the Town of Dryden and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of Gaylord and the Town of Dryden indicating their desire that certain property be annexed to the City of Gaylord pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on August 3, 1988, the Minnesota Municipal Board has reviewed and approved the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Gaylord, Minnesota, the same as if it had originally been made a part thereof:

Lots 1, 2, 3, 4, 5, 6, and 7 of KLIMMEK'S FIRST ADDITION, Sibley County, Minnesota according to the recorded plat thereof, also all that part of County State Aid Highway No. 21 right-of-way lying between the southerly extensions of the east line of said Lot 7 and


the west line of said Lot 1, of KLIMMEK'S FIRST ADDITION, also that part of C.S.A.H. No. 21 right-of-way lying along the northerly portion of Lot 8 of said KLIMMEK'S FIRST ADDITION lying between the east and west lines of said Lot 8.

IT IS FURTHER ORDERED: That the mill levy of the property herein ordered annexed shall be increased in substantially equal proportions over a period of three years to equality with the mill levy of the property already within the city.

IT IS FURTHER ORDERED: That the effective date of this order is August 3, 1988.
