An Unsurveyed Island located on the Section Line between Sections 21 and 22, Township 65 North, Range 10 West, 4th P.M., lying due North 850 feet from the M.C. on the Northwest Corner of Lot 4 of Section 22 of said Township, containing approximately 27.00 acres.

An Unsurveyed Island located in the Northern portion of the NW $\frac{1}{4}$  of Section 28, Township 65 North, Range 10 West, 4th P.M., lying South 70° West 4000 feet from the M.C. on the Northeast Corner of Lot 1 of Section 21-65-10, containing approximately 4.50 acres.

An Unsurveyed Island located in the Northern portion of the NW $\frac{1}{4}$  of Section 28, Township 65 North, Range 10 West, 4th P.M., lying South 74° West 4430 feet from the M.C. on the Northeast corner of Lot 1 of Sec. 21-65-10, containing approximately 3.00 acres.
