

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF SPRING GROVE

The City Council of the City of Spring Grove, Minnesota ordains:

That Whereas, a petition has been duly filed with the City Clerk requesting the annexation to the City of Spring Grove of certain territory therein and here in after described, and wheras a hearing has been held on the 19th. day of July, 1988 A.D. in the City Hall in the City of Spring Grove, to consider the proposed annexation and any arguments for and against the same, and Whereas the Council has found theat the petition was in proper form and duly signed by a majority of the owners of the land described, and that 30 days posted notice and adertisement in theofficial newspapers was given as provided by law,

And Whereas, the council at said hearing has found that the Land described and in said petition is so conditioned as properly to be subject to the City Government, and has determined that the annexation will be in the best interest of the city and the territory affected,

Now Therefor be it ordained, that the City Council of the City of Spring Grove, Houston County, Minnesota does hereby

ordain and declare annexed to said City of Spring Grove, Houston County, Minnesota, the following described territory;

Lot 6 and lot 7 of block 3 of Ingvald Muller's First Addition to the City of Spring Grove, Minnesota and the adjoining streets and alleys; the entire arear is more particularly described as follows:

Commencing at the southwest corner of lot 7 of block 3 of Ingvald Muller's First Addition to the City of Spring Grove, thence West 50', thence North 100', thence East 470', thence Wouth 100', thence West 420' West to the point of beginning.

This ordinance becomes effective from and after it's passage and publication.

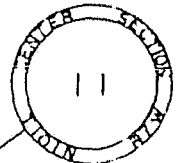
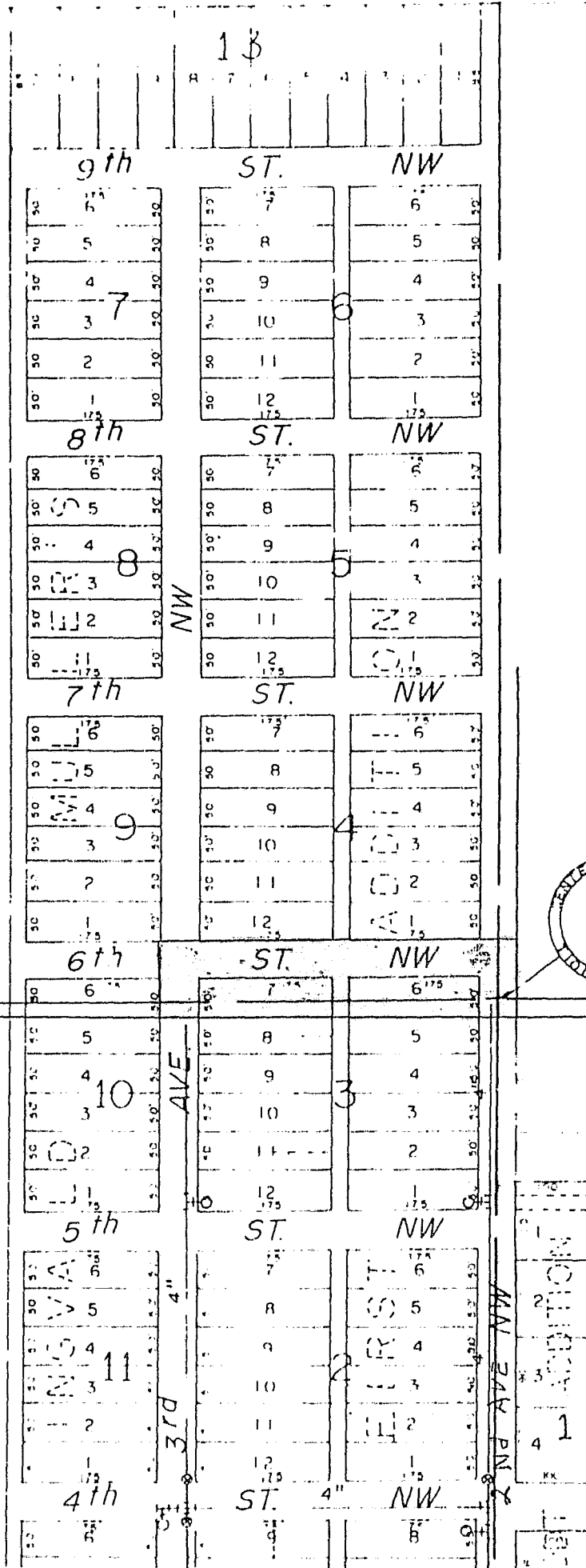

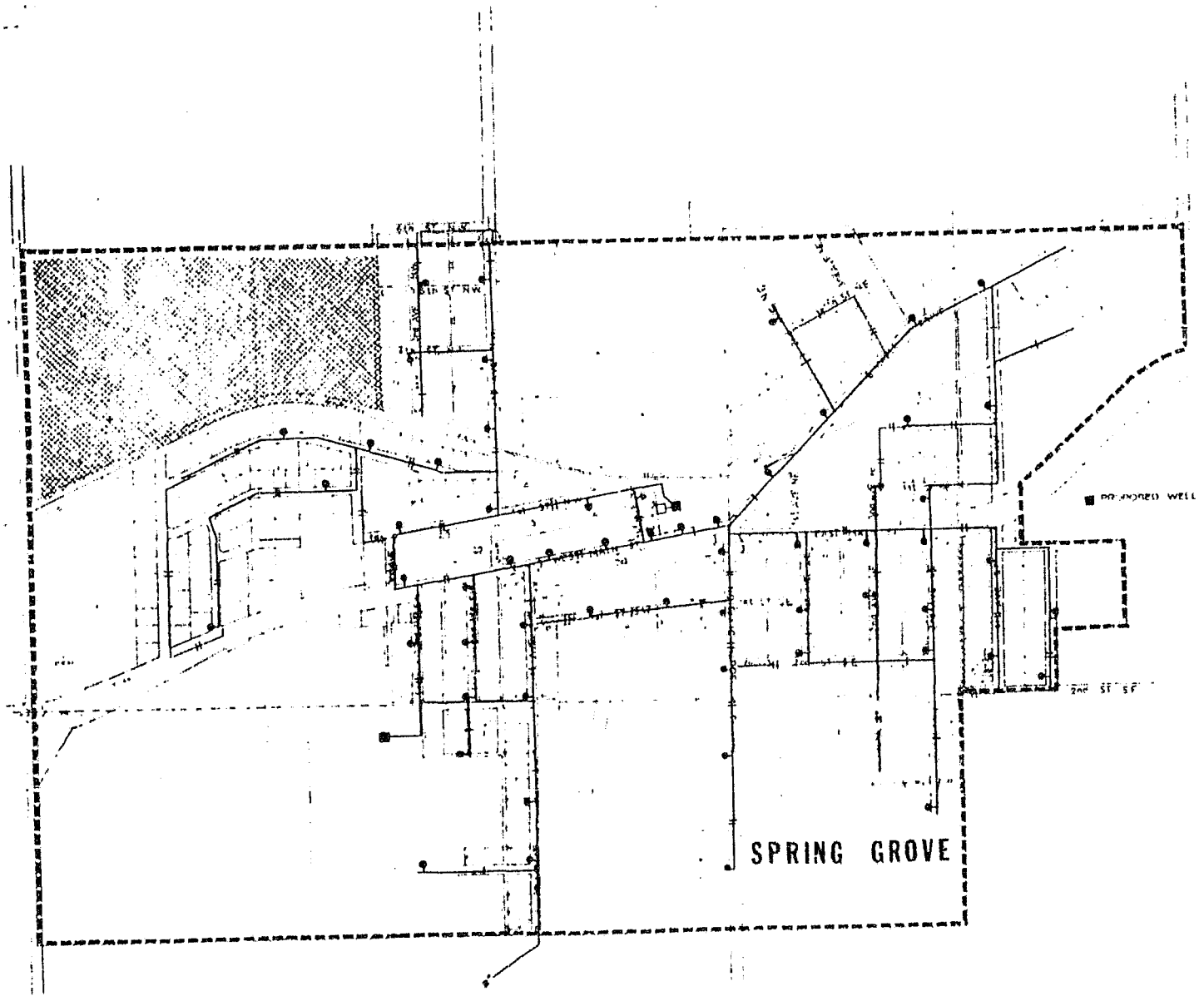
