<u>ORDER</u>

WHEREAS, joint resolutions for orderly annexation were adopted by the City of Staples and the Towns of Staples and Thomastown and duly accepted by the Minnesota Municipal Board; and

WHEREAS, said joint resolutions requested that certain property be annexed to the City of Staples pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on September 2, 1988, the Minnesota Municipal Board has reviewed and accepted the resolutions for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Staples, Minnesota, the same as if it had originally been made a part thereof:

> The Southeast Quarter (SE1/4) of Section 34, Township 134 North, Range 33 West, consisting of 160 acres, more or less, and the Southeast Quarter (SE1/4) of Section 26, Township 134 North, Range 33 West, consisting of 160 acres, more or less, and the North Half of the Southwest Quarter (N1/2 of SW1/4), of Section 25, Township 134 North, Range 33 West, consisting of 80 acres, more or less, as situated in Thomastown Township, Wadena County, Minnesota, including all abutting streets, alleys and roadways.

The Southeast Quarter of the Northeast Quarter (SE1/4 of NE1/4) and the North Half of the Northwest Quarter (N1/2 of NW1/4) and the Northwest Quarter of the Northeast Quarter (NW1/4 of NE1/4) of Section 2, Township 133 North, Range 33 West, consisting of 142.23 acres, more or less; and that part of the Southwest Quarter of the Northeast Quarter (SW1/4 of NE1/4) of Section 2, Township 133 North, Range 33 West described as follows: Commencing at the northeast corner of said SW1/4 of NE1/4; thence South along the East line of said SW1/4 of NE1/4 a distance of 330 feet; thence West and parallel with the north line of said SW1/4 of NE1/4 a distance of 330 feet; thence North and parallel with the east line of said SW1/4 of NE1/4 a distance of 330 feet to the north line thereof; thence East along said north line a distance of 330 feet to the point of beginning, consisting of 2.5 acres, more or less; and the Northeast Quarter (NE1/4) of Section 3 and that part of the North Half of the Southeast Quarter (N1/2 of SE1/4) which lies northerly of the railroad and highway right-of-way of Section 3, all in Township 133 North, Range 33 West, consisting of 208.75 acres, more or less, as situated in Staples Township, Todd County, Minnesota, including all abutting streets, alleys and roadways.
