REORGANIZATION ORDER NO. 155

Pursuant to Minnesota Statutes 1986, Section 16B.37, the following administrative reorganization is made with the prior approval of the Governor.

In order to improve efficiency and avoid duplication in the operation of state government, the powers and duties of the Waste Management Board are transferred to the Pollution Control Agency and the Environmental Quality Board as set forth below.

The following powers and duties of the Waste Management Board are transferred to the Pollution Control Agency:

1. All powers necessary or convenient to discharge the duties transferred pursuant to this Order (Section 115A.06, subd. 1).
2. To promulgate rules (Section 115A.06, subd. 2).
3. To sue and be sued (Section 115A.06, subd. 3).
4. To enter property for the purpose of obtaining information and to pay a reasonable estimate of the damages it believes will be caused (Section 115A.06, subd. 5).
5. To acquire easements (Section 115A.06, subd. 5a).
6. To apply for and accept gifts, loans, or other property (Section 115A.06, subd. 6).
7. To own, use, or occupy property exempt from taxation except for special assessments (Section 115A.06, subd. 7).
8. To enter into contracts (Section 115A.06, subd. 8).
9. To engage in joint cooperative action (Section 115A.06, subd. 9).
10. To conduct research studies and programs and other related activities in accordance with section 115A.06, subd. 10.
11. To employ persons and contract for services (Section 115A.06, subd. 11).

12. To procure insurance and to require any employee to obtain and file with it an individual bond or fidelity insurance policy (Section 115A.06, subd. 12).
13. To use classified or nonpublic data in accordance with Section 115A.06, subd. 13.
14. To encourage improved management of nonhazardous and industrial waste (Section 115A.06, subd. 14).
15. To inform the Commissioner of Trade and Economic Development of the agency's activities (Section 115A.07, subd. 1).

23. To establish a technical and research assistance program in accordance with Section 115A.152.
24. To make waste reduction grants to generators of hazardous waste (Section 115A.154).
25. To make development grants for waste processing and collection facilities (Section 115A.156).
26. To request proposals for the development and operation of commercial hazardous waste and processing facilities in accordance with Section 115A.158.
27. To request proposals for the development and operation of hazardous waste collection and transportation services in accordance with Section 115A.159.

28. To review and certify applications for hazardous waste processing facility loans (Section 115A.162).
29. To evaluate its programs in accordance with Section 115A.165.
30. To assist and encourage the development of specific facilities, services, and uses needed to provide markets for recyclable materials and compost generated in the state (Section 115A.48).
31. To administer a program to encourage and improve regional and local solid waste management planning activities (Sections 115A.42 to 115A.46).
32. To provide grants to develop waste reduction and separation projects (Section 115A.53).
33. To establish a solid waste management demonstration program in accordance with Sections 115A.49 to 115A.541.
34. To authorize disbursements from the waste management fund (Section 115A.57).
35. To request the Commissioner of Finance to sell waste management bonds (Sections 115A.58, subd. 2 and 115A.59).
36. To establish, alter and terminate solid waste management districts in accordance with Sections 115A.63 to 115A.72.
37. To approve solid waste designation plans, ordinances, and contracts, and to supervise implementation of such plans (Sections 115A.84, 115A.86, 115A.89).
38. To implement the waste tire management program in accordance with Sections 115A.912 to 115A.914.
39. To make loans to businesses for the purchase of used oil processing equipment (Section 115A.9162, subd. 1).
40. To make grants to counties for installation of storage tanks to collect used oil (Section 115A.9162, subd. 2).
41. To issue certificates of need for new capacity for disposal of mixed municipal solid waste @Section 115A.917).
42. To develop guidelines for counties to use to identify ways to meet the goals in Section 115A.97 (Section 115A.97, subd. 5).

43. To develop and propose statewide goals and timetables for the reduction of the noncombustible fraction of mixed municipal solid waste (Section 115A.97, subd. 5).

The following powers and duties of the Waste Management Board are transferred to the Environmental Quality Board:

1. All powers necessary or convenient to discharge the duties transferred pursuant to this Order (Section 115A.06, subd. 1).
2. To promulgate rules (Section 115A.06, subd. 2).
3. To sue and be sued (Section 115A.06, subd. 3).
4. To direct the Commissioner of Administration to acquire property for sites and buffer areas surrounding sites for stabilization and containment facilities (Section 115A.06, subd. 4).
5. To enter property for the purpose of obtaining information and to pay a reasonable estimate of the damages it believes will be caused (Section 115A.06, subd. 5).
6. To acquire easements (Section 115A.06, subd. 5a).
7. To apply for and accept gifts, loans, or other property (Section 115A.06, subd. 6).
8. To own, use, or occupy property exempt from taxation except for special assessments (Section 115A.06, subd. 7).
9. To enter into contracts (Section 115A.06, subd. 8).
10. To engage in joint cooperative action (Section 115A.06, subd. 9).
11. To conduct research studies and programs and other related activities in accordance with section 115A.06, subd. 10.
12. To employ persons and contract for services (Section 115A.06, subd. 11).
13. To procure insurance and to require any employee to obtain and file with it an individual bond or fidelity insurance policy (Section 115A.096, subd. 12).

14. To use classified or nonpublic data in accordance with Section 115a.06, subd. 13.
15. To proceed with selection and evaluation of sites for stabilization and containment facilities in accordance with sections 115A.175 to 115.39.

Consistent with this transfer of powers and duties, the following positions and their incumbents, with all accrued benefits, are transferred from the Waste Management Board to the Pollution Control Agency.

The General Fund complement of the Waste Management Board as provided by Laws 1987, Ch. 404, Sec. 24 is decreased by 32 positions; the General Fund complement of the Pollution Control Agency as provided by Laws 1987, Ch. 404, Sec. 24, is increased by 32 positions.

The Special Revenue Fund complement of the Waste Management Board as provided by Laws 1987, Ch. 348 and Laws 1988, Ch. 68, is decreased by 5 positions; the Special Revenue Fund complement of the Pollution Control Agency as provided by Laws 1987, Ch. 404, Sec. 24, is increased by 5 positions.

The Motor Vehicle Transfer Fund complement of the Waste Management Board as provided by Reorganization Order 144, and Laws 1987, Ch. 404, Sec. 25, and Laws 1988, Ch. 685, is decreased by 8 positions; the Motor Vehicle Transfer Fund complement of the Pollution Control Agency as provided by Laws 1987, Ch. 404, Sec. 24, is increased by 8 positions.

The Building Fund complement of the Waste Management Board as provided by Laws 1987, Ch. 404, Sec. 25, and Laws 1987, Ch. 400, Section 6, and Laws 1988, Ch. 685 is decreased by 18 positions; the Building Fund complement of the Pollution Control Agency as provided by Laws 1987, Ch. 404, Sec. 24, is increased by 18 positions.

The board, composed of nine permanent members and other temporary members pursuant to Section 115A.05, is abolished except that the complement position of chair is transferred to the Pollution Control Agency.

Nothing in this reorganization order shall be construed as abrogating or modifying any rights now enjoyed by affected employees under the managerial or commissioner's plan under Minnesota Statutes 1986, Section 43A.18 or the terms of an agreement between an exclusive representative of public employees and the state or one of its appointing authorities.

The Waste Management Board shall give to the Pollution Control Agency and the Environmental Quality Board all contracts, books, maps, plans, papers, records, supplies, and equipment relevant to their respective duties and powers imposed by this order.

The rules promulgated by the Waste Management Board shall continue in force and effect under the jurisdiction of the Environmental Quality Board and the Pollution Control Agency, as applicable. However, the rules relating to the operating procedures of the Environmental Quality Board and Pollution Control Agency shall supersede the rules relating to operating procedures promulgated by the Waste Management Board.

Any proceeding, court action, prosecution, or other business or matter pending on the effective date of the transfer may be conducted and completed by the Pollution Control Agency or the Environmental Quality Board, as the case may be, in the same manner under the same terms and conditions, and with the same effect, as though it involved or were commenced and conducted or completed prior to the transfer by the Waste Management Board.

All Powers and duties conferred on the chair of the Waste Management Board shall transfer to the Commissioner of the Pollution Control Agency and the Chair of the Environmental Quality Board, as applicable.


The Environmental Quality Board and the Pollution Control Agency shall adhere to all applicable legislative policies in carrying out the powers and duties transferred by this Order.

The primary intent of this Order is to transfer to the Environmental Quality Board the powers and duties necessary to carry out the selection, evaluation, and development of sites for stabilization and containment facilities and transfer all other powers and duties to the Pollution Control Agency. The Environmental Quality Board and the Pollution control Agency shall cooperate with each other to facilitate and carry out the intent of this Order. The two agencies shall jointly report to the governor on the progress of the transfer of powers and duties and recommend any necessary adjustments needed to further improve efficiency and avoid duplication.


The Commissioner of Finance shall make the necessary financial determinations in accordance with Minnesota Statutes 1986, Section 16B.37, Subdivision 3.





SUBJECT: AUTHORITY TO CONDUCT FISCAL, ADMINISTRATIVE AND PERSONNEL FUNCTIONS

By Reorganization order No. 155, dated October 7, 1988, the Governor transferred the powers and duties of the Waste Management Board to the Pollution Control Agency with responsibility for the development of a hazardous waste stabilization and containment facility going to the State Planning Agency. The Pollution Control Agency integrated the functions of the Waste Management Board into its organization by establishing an Office of Waste Management Grants and Assistance, Office of Waste Tire Management, and the implementation of an Interagency Agreement with State Planning regarding the Hazardous Waste Siting Program. Since October 7, 1988 the Pollution Control Agency has conducted the programs and administration of the former Waste Management Board as an integral part of its organization.

The 1989 Legislature reestablished the Office of Waste Management as an independent State agency with all of the responsibilities of the former Waste Management Board with the exception of Waste Tire Management which remains with the Pollution Control Agency. The Office of Waste Management was established with a complement of only 22 and an effective date of July 1, 1989. Additional complement of 26 for the Office of Waste Management was tied to the SCORE legislation which was not passed by the Legislature. There is a possibility that SCORE will be addressed in a Special Session or the 1990 Session.

Due to the small size of the Waste Office and its level of responsibility, it seems appropriate that the Pollution Control Agency continue to perform all of the fiscal, administrative and personnel functions for the new Waste Office as it did when the Waste Office was a part of the Pollution Control Agency. It is necessary for such functions as payroll, year end close out activities, payment of bills, deposit of receipts, initiation of the 1990 spending plan, procurement and personnel activities to continue uninterrupted.

This memorandum requests that you continue the fiscal, administrative and personnel system authorizations currently in effect so that the Pollution Control Agency can continue to provide administrative support to the Office of Waste Management. The Pollution Control Agency will ensure that all activities performed by itself as agent for the Waste Office will be separate from its on-going activities so that there will be no confusion or questions of accountability regarding the resources and responsibilities of each agency.

An Interagency Agreement between the Pollution Control Agency and the Office of Waste Management has been drafted. This document establishes the responsibilities and limits of each agency regarding the conduct of the fiscal, administrative and personnel activities. Each of you will be requested to sign this agreement in the near future. The effective date of this agreement will be July 1, 1989.
