WHEREAS, on October 13, 1988, the Minnesota Municipal Board has reviewed and approved the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Austin, Minnesota, the same as if it had originally been made a part thereof:

> Beginning at the northeast corner of Lot 11, Block 2, Oak Ridge Addition, Mower County, Minnesota, thence westerly along the north line of said Block 2 extended to the west property line of 23rd Street S.W. which is also the east line of Block 1 of said Oak Ridge Addition thence southerly along the west property line of 23rd Street

S.W. to the south property line of 9th Avenue S.W. thence easterly along the south property line of 9th Avenue S.W. until it intersects the east line of said Lot 11, Block 2, extended southerly thence northerly on this extension to the northeast corner of said Lot 11 and the point of beginning. 1.5 acres.
