

SHALL THE CHARTER AMENDMENT, IDENTIFIED IN THE UNDERLINED PORTION BELOW, BE ADOPTED?

"NO MEMBER OF THE COUNCIL SHALL BE APPOINTED CITY MANAGER, NOR SHALL ANY MEMBER HOLD ANY OTHER PAID MUNICIPAL OFFICE OR EMPLOYMENT UNDER THE CITY; AND UNTIL ONE YEAR AFTER THE EXPIRATION OF HIS TERM AS MAYOR OR COUNCILMAN NO FORMER MEMBER SHALL BE APPOINTED TO ANY PAID APPOINTIVE OFFICE OR EMPLOYMENT UNDER THE CITY WHICH OFFICE OR EMPLOYMENT WAS CREATED OR THE EMOLUMENTS OF WHICH WERE INCREASED BY THE COUNCIL DURING HIS TERM AS COUNCILMAN. WITHIN THIS SECTION, "UNDER THE CITY" SHALL INCLUDE BUT NOT BE LIMITED TO THE HOUSING AND REDEVELOPMENT AUTHORITY, THE BLOOMINGTON PORT AUTHORITY, AND ANY OTHER ENTITY THE MEMBERS OF WHICH ARE APPOINTED BY, POLICY IS ESTABLISHED BY, OR WHICH IS FINANCED BY, THE CITY."
