



IN THE MATTER OF THE ORDERLY ANNEXATION)
AGREEMENT BETWEEN THE CITY OF BLOOMING) ORDER
PRAIRIE AND THE TOWN OF WESTFIELD)
PURSUANT TO MINNESOTA STATUTES 414)

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Blooming Prairie and the the Town of Westfield and duly accepted by the Minnesota Municipal Board; and

WHEREAS, said joint resolution requested that certain property be annexed to the City of Blooming Prairie pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on November 2, 1988, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Blooming Prairie, Minnesota, the same as if it had originally been made a part thereof:

The Northwest Quarter of the Southwest Quarter of Section 30, Township 105 North, Range 18 West, Dodge County, Minnesota, excepting

the Northerly 425 feet of the Easterly 300 feet thereof, containing 37.08 acres.

IT IS FURTHER ORDERED: That the effective date of this order is November 2, 1988.
