



AGREEMENT BETWEEN THE CITY OF HASTINGS) ORDER
AND THE TOWN OF MARSHAN PURSUANT TO)
MINNESOTA STATUTES 414)

WHEREAS, a Joint resolution for orderly annexation was adopted by the City of Hastings and the Town of Marshan and duly accepted by the Minnesota Municipal Board; and

WHEREAS, an amendment to the Joint resolution was adopted by the City of Hastings and the Town of Marshan and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of Hastings and the Town of Marshan indicating their desire that certain property be immediately annexed to the City of Hastings pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on February 2, 1989, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Hastings, Minnesota, the same as if it had

originally been made a part thereof:

Property located in Section 4 Township 114 R17 described as part of N1/2 of NE1/4 Beginning 33 feet West and 33 feet South of NE Corner of NE1/4 of NE1/4, thence West 80 Ft., thence South 60 ft., thence East 80 ft., and thence North 60 ft., to the beginning.

IT IS FURTHER ORDERED: That the effective date of this order is February 2, 1989.
