
The Minnesota Municipal Board has now processed and approved the above ordinance in accordance with Minnesota Statutes, Chapter 414, and the Rules of Procedure.



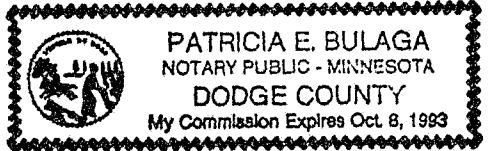

ORDINANCE #628

AN ORDINANCE AMENDING ORDINANCE NO. 617 ANNEXING TO THE CITY OF KASSON, MINNESOTA, CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES, BEING LOCATED IN SECTION 33, AND SECTION 34, MANTORVILLE TOWNSHIP, DODGE COUNTY, MINNESOTA

THE CITY COUNCIL OF THE CITY OF KASSON, MINNESOTA DOES ORDAIN:

Section 1. A petition has been filed with the City Council of the City of Kasson, signed by all of the owners of the land described herein, requesting the City Council to annex said land to the City of Kasson. The land described in said petition for annexation is located in Mantorville Township, Dodge County, Minnesota described as follows:

Revised Annexation Description for:

William Konrath & Rosemary Konrath

That part of the Northeast Quarter of the Northeast Quarter of Section 33 and of the West One-Half of the Northwest Quarter of Section 34, Township 107 North, Range 16 West, Dodge County, Minnesota, described as follows:

Commencing at the southeast corner of the Northeast Quarter of said Section 33; then N01 07'04"W, assumed bearing, along the east line of said Section 33, a distance of 452.58 feet to the northerly right of way line of the Chicago and Northwestern Railroad for a point of beginning; thence continue N01 07'04"W, along the east line of said Section 33, a distance of 887.27 feet to the northeast corner of Huse's Third Subdivision; thence S88 57'05"W, along the north line of said Huse's Third Subdivision, 134.90 feet to the southeast corner of Blaine's Eighth Subdivision; thence N00 56'17"W, along the east line of said Blaine's Eighth Subdivision, 184.94 feet to the north line of Fourth Street N.E. as platted in said Blaine's Eighth Subdivision; thence S89 03'16"W, along the north line of said Fourth Street N.E., if extended easterly, 297.27 feet; thence S05 47'29"E, 1033.12 feet to the northerly right of way line of said Chicago and Northwestern Railroad; thence S79 17'00"W, along said right of way line, 250.64 feet to the point of beginning.

Containing 5.54 acres, more or less.

Section 2. Said amended petition has been filed with the Town Board of Mantorville Township, with the County Auditor of the County of Dodge, the Secretary of State and the Minnesota Municipal Commission.

Section 3. Pursuant to a resolution, a copy of which is attached hereto and made a part hereof, duly adopted by the Township Board of Mantorville Township on March 7, 1988, said town board waived its right to object to the annexation of the land described herein, thereby waiving the 90 days as provided by Minnesota Statutes before a City ordinance could be adopted annexing said described land.

Section 3A. Pursuant to an attachment duly accepted by the Mantorville Township Board, the revised and corrected property description of the land to be annexed is hereby approved.

Section 4. The City Council of the City of Kasson does hereby determine that the land so described in Section 33 and 34, Mantorville Township abuts upon the present territorial limits of the City of Kasson, is so conditioned as to be properly subjected to municipal government, and the annexation of said land will be in the best interest of the City of Kasson and the land affected.

Section 5. Therefore, the land so described as being in Section 33 and 34, Mantorville Township is hereby annexed, added to and made a part of the City of Kasson, Minnesota, as effectually as if it had originally been a part thereof.

Section 6. Present and future owners of the area annexed by this ordinance are hereby notified that in addition to the usual assessments, it is the intention of the City Council to assess against said annexed property all or a portion of the cost of any water lines, trunk line sanitary sewer, service connections and street construction, heretofore or hereafter undertaken to serve the area annexed.

Section 7. Pursuant to Article 1 - Section 1.05 of Ordinance Number 523, known as the Zoning Ordinance of the City of Kasson, Minnesota, the lands herein annexed to the City of Kasson shall be designated as residential.

Section 8. This ordinance shall take effect and be in force from after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Commission, the Mantorville Township Clerk, the Dodge County Board and the Secretary of State.

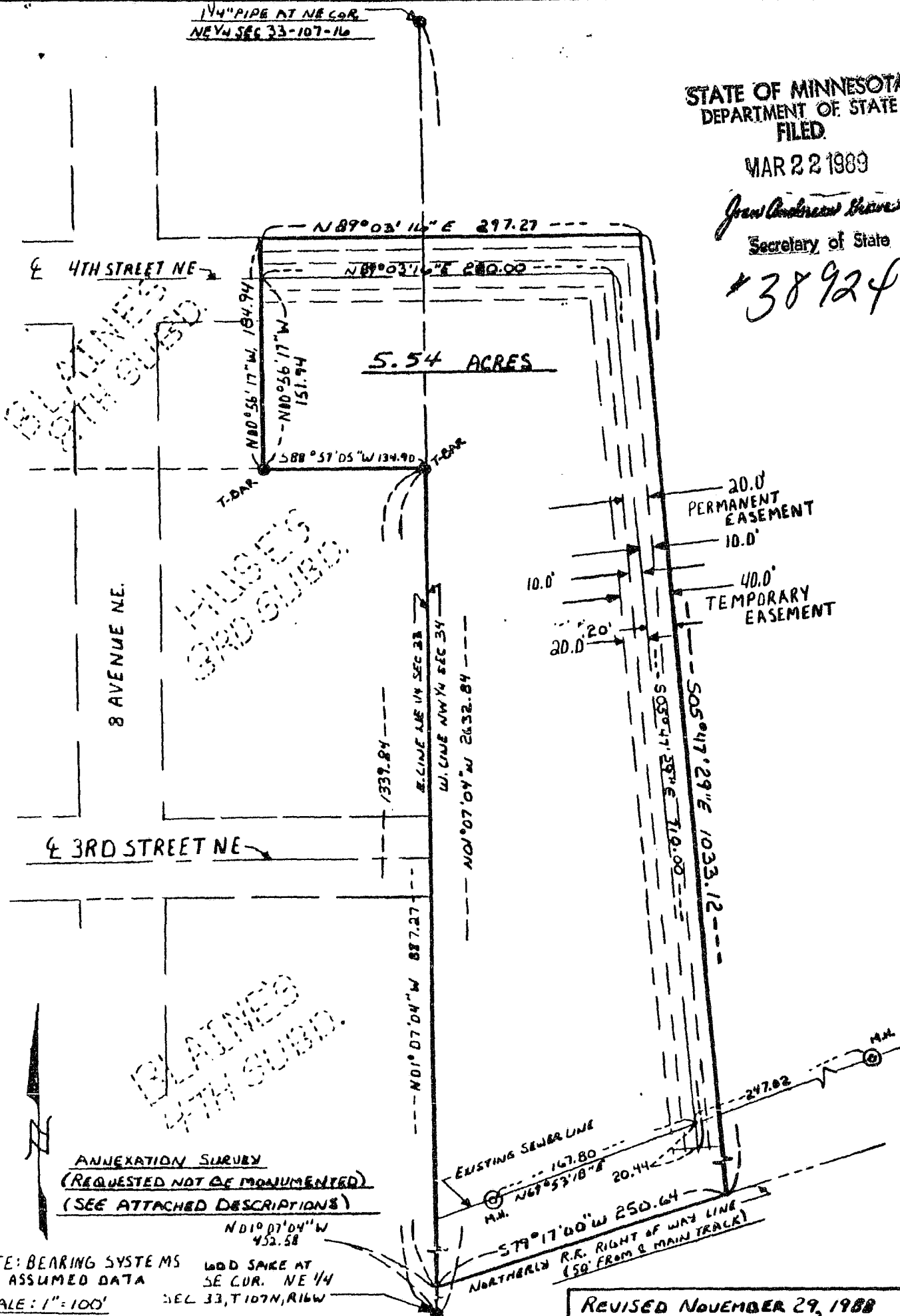

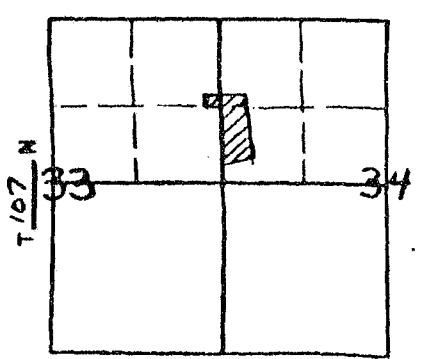


ANNEXATION SURVEY
