AN ORDINANCE ANNEXING
KARVEL PROPERTY TO THE
CITY OF WAITE PARK
The City Council of Walte
Park, Minnesota, ordains as follows:
1. That the City

1. That the City has been deeded and is the owner of property lying in Stearns County legally described as follows:
All that part of the Northwest Quarter of the Northwest Quarter (NWV. of NWV.) of Section Seventeen (17), Township One Hundred Twenty-four (124) North, Range Twenty-eight (28) West, lying Easterty of the East Bank of Sauk River and North and West of the Center line of County Ald Road #138 and North of the following described line: Commencing at the point of Intersection of the westerty right-of-way line of County Ald Road #138, and the Northerty right-of-way line of Old Trunk Highway #52 and assuming the bearing of said Northerty right-of-way line of Old Trunk Highway #52, to be, South 82 degrees 36 minutes East along said Westerdy right-of-way line of Old Trunk Highway #52, to be, South 82 degrees 36 minutes East along said Westerdy right-of-way line of Ocounty Ald Road #138, a distance of 1190.15 feet to the point of beginning of the line herein described; thence North 82 degrees 36 minutes West, for a distance of 589,70 feet, more or less, to a point on the East Bank of the Sauk River and there terminating. In Stearns County, Minnesota.

Pursuant to Minn. Stat. 414 033, the City Council is empowered to annex the property without further notice in the event that the land is owned by the municipality.

The City of Waite Park, by power vested pursuant to Minnesota Haw, does hereby annex the property referred to in Paragraph 1 of this Ordinance.


