We, the undersigned, being legal voters in the County of Winona, in the State of Minnesota respectfully petition your Honorable body to call an election for the determination of the proposed incorporation of the following described territory in the Township of Norton in the County of Winona and State of Minnesota; to-wit, All of Section Number Seven (7) all of Section Number Eight (8) all of Section Number Eighteen (18), all of Section Number Nineteen (19) the North one-half of Section Number Twenty (20) the North one half (½) of Section Number Seventeen (17) and the South West quarter (¼) of Section Number Seventeen (17), all in Township Number One Hundred and Seven (107) North of Range Nine (9) West into the Village of Altura and which shall be known as and called the Village of Altura;


