AN ORDINANCE ANNEXING PROPERTY TO
THE CORPORATE LIMITS OF THE
CITY OF MANKATO AT THE
INTERSECTION OF MADISON AVENUE AND
THE HIGHWAY 22 BYPASS

WHEREAS, the owners of the property which is described in Exhibit "A", which is attached hereto and incorporated herein by reference, have petitioned to have such property annexed to the corporate limits of the City of Mankato; and

WHEREAS, such property is not presently included in the corporate limits of any incorporated city, village or borough; and

WHEREAS, such property does not exceed 200 acres; and

WHEREAS, the petitioning owners own all of the land to be annexed; and

WHEREAS, no person live on the property; and

WHEREAS, the property requires municipal services from the City of Mankato; and

WHEREAS, annexation of the property pursuant to Minnesota Statutes §414.033 Subd. 5 is appropriate.

NOW, THEREFORE, the City of Mankato hereby ordains that the corporate limits of the City of Mankato are hereby extended to include the land described in Exhibit "A", and the same is hereby annexed to an included within the corporate limits of the City of Mankato as effectively as if it had originally been a part thereof and the City Clerk is hereby directed to file copies of this ordinance with the Minnesota Municipal Board, the Blue Earth County Auditor and the Mankato Town Board.

This Ordinance shall become effective after its approval by the Minnesota Municipal Board and thirty days after its passage and publication.
