ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Morris and the Town of Darnen and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of Morris and the Town of Darnen indicating their desire that certain property be annexed to the City of Morris pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on April 11, 1989, the Minnesota Municipal Board has reviewed and approved the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Morris, Minnesota, the same as if it had originally been made a part thereof:

A parcel of land in the SW 1/4 SW 1/4 of Section 1, Township 124 North, of Range 42 West, Stevens County, Minnesota, excepting the following parcel: Beginning at the NE corner of the SW 1/4 SW 1/4 of said Section 1, thence South along the East line of the SW 1/4 SW 1/4, 815 feet more or less, thence in a northwesterly direction to a point on the North line of said SW 1/4 SW 1/4, said point being 200

feet more or less East of the West line of said Section 1, thence East along said North line of said SW 1/4 SW 1/4, 1125 feet more or less to the point of beginning as shown on the location map for said Project Number 9 of the Pomme de Terre River Emergency Relief Administration, State of Minnesota, dated June 3, 1935, and revised July 11, 1935.

IT IS FURTHER ORDERED: That the effective date of this order is

April 11, 1989.
