ORDINANCE NO. 89 - 14

AN ORDINANCE AMENDING SECTIONS 4.01, 4.02 AND 4.04 OF THE BLOOMINGTON CITY CHARTER BY CHANGING THE DATES FOR CANDIDATE FILING AND PRIMARY ELECTIONS TO COMPLY WITH MINNESOTA STATUTES AND TO REMOVE OUT OF DATE REFERENCES TO VOTING MACHINES, TALLY BOOKS, AND MUNICIPAL JUDGES

The City Council of the City of Bloomington hereby ordains:

Section 1. That Sections 4.01, 4.02, and 4.04 of the Bloomington City Charter are hereby amended to read as follows:

#### CHAPTER 4

#### NOMINATIONS & ELECTIONS

# SEC. 4.01. THE REGULAR MUNICIPAL ELECTION.

Regular municipal elections shall be held on the first Tuesday after the first Monday of November in 1961, 1962, 1963, 1965 for the election of the officers as provided in Chapter 2. Regular municipal elections shall be held on the first Tuesday after the first Monday of November of each odd numbered year commencing in 1965. Such elections shall be held at such place or places as the city council shall designate. The city clerk shall give notice to all elections in the manner prescribed by the laws of Minnesota for cities of the same classification as Bloomington, but failure to give such notice shall not invalidate such election. At the regular election there shall be elected [, in addition to] the members of the council [, such municipal judges as may be provided by law].

### SEC. 4.02. PRIMARY ELECTIONS.

On the <u>first</u> Tuesday <u>after the second Monday in September</u> [four weeks] in advance of the regular municipal election there shall be a primary election for the selection of two nominees for each elective office at the regular municipal election, unless only two nominees file for each elective office.

# SEC. 4.04. FILING OF CANDIDATES.

All elective officers provided for by this charter who shall desire to be elected to any elected office shall file an affidavit not more than [six]ten weeks nor less than [four]eight weeks before the primary election with the city clerk, paying to such officer a fee of \$2.00. The city clerk shall prepare and have printed at the expense of the city the necessary [tally books and] ballots or other required material [for voting machines] for such election. [The ballots or other required material for voting machines shall be printed.] ballots or other material [for voting machines] shall contain no political party designation of any candidate and the names of the candidates for each office may be arranged on the ballot alphabetically according to the surname of each candidate. The ballots or the results [obtained from voting machines] shall be counted and preserved and the city clerk shall be the final custodian of such ballots or returns [from voting machines] for the city. A sample ballot or a facsimile representation of the <u>ballot</u> [control panel of the voting machine] shall be posted at the place of election at least one week before such election by the city clerk, whose duty it is to preserve such sample ballots.
