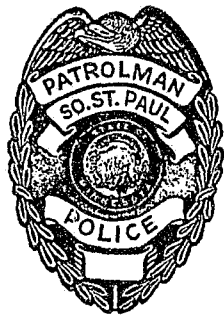

### ARTICLE IX

#### SECTION 4

A member's pension rights shall be vested after five years of creditable service.

Any member of the Association who leaves the service of the South St. Paul Police Department with five or more creditable years of service, but less than twenty creditable years of service, shall be entitled to a reduced service pension at age 50. The reduced service pension shall be a pro rata amount, expressed as a fraction with the denominator 20 and the numerator the number of years of creditable service completed, of a normal service pension.

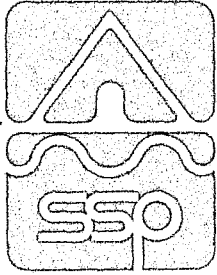
The surviving spouse and surviving child(ren) of a reduced service pensioner shall be entitled to a pension under Article XII, subject to the same pro rata reduction listed above.

Any reduced service pension shall be subject to the same percentage post retirement adjustment as a normal service pension.
