

ORDER

WHEREAS heretofore and on February 27, 1989 a petition signed by Ivan Petersen and others dated February 20, 1989 constituting more than twenty legal voters residing within Clough Township was presented to the County Board of Commissioners of Morrison County and filed with the County Auditor; and

WHEREAS said petition alleges that a great portion of the land in Clough Township is owned by and under the control of Camp Ripley Military Reservation and that the remainder of the lands in the township owned by private parties and persons is too small of an area in size to justify the continuation of its independent township form of government; and

WHEREAS it was made to appear that a copy of the petition dated February 20, 1989 signed by Ivan Petersen and others, together with a copy of the Notice of Hearing on said matter dated February 27, 1989 were either published and/or posted according to law in both Cushing Township and Clough Township; and

WHEREAS a copy of the petition and a copy of the Notice of Hearing were served upon Carl E. Johnson, Clerk of Cushing Township, and Glenn Thelen, Clerk of Clough Township; and

WHEREAS said matter came on for hearing before the Morrison County Board of County Commissioners in the Morrison County Administration Building in Little Falls, Minnesota at 11:00 o'clock a.m. on April 18, 1989; and

WHEREAS the County Board of Commissioners having received testimony and evidence from all persons interested in the matter and having been advised of the merits of the petition makes the following:

ORDER

1. That the petition is in all respects legal, that notice of said hearing has been provided according to law and that all proceedings are in accordance with the laws of the State of Minnesota.

2. That all lands located in Clough Township, more particularly described as Sections 1-36 in Township 131 North Range 30 West and Sections 5, 6, 7, 8, 18, 19, 30, 31 and 32 in Township 131 North Range 29 North are hereby attached to and made a part of the Township of Cushing in Morrison County, more particularly described as Township 131 North Range 31 West; that the boundary of the Township of Cushing is hereby altered to include the above-described lands located in the Township of Clough.

3. That from and after April 18, 1989 the entire area herein before described as being in the Township of Clough is hereby and herewith attached to and made a part of the Township of Cushing; that

all of the assets of the Township of Clough are hereby and herewith transferred and assigned to the Township of Cushing; that the Township of Clough has no debts.

4. That all further proceedings shall be in accordance with the laws of the State of Minnesota.
