



RESOLUTION 89-30
RESOLUTION ADOPTING FARIBAULT FIREFIGHTER RELIEF
ASSOCIATION'S REDUCTION OF VESTED PENSION BYLAW

WHEREAS, M.S.A 423A subdivision 1, allow police or salaried firefighters relief associations to implement a reduced vesting provision with municipal approval that states, "a person with at least five years of service credited by the relief association is entitled, upon termination of active service and reaching at least the required normal retirement age, to receive a pro rata monthly service pension. The pro rata monthly service pension must be calculated in the amount and manner specified by the board of trustees, but not to exceed that portion of the service pension payable upon meeting the minimum age and years of service requirements that bears the same relationship that the persons's actual years and portions of service bear to the minimum service requirement; and,

WHEREAS, the Faribault Fire Department Relief Association has petitioned the City, per M.S.A 423A subdivision 4, to adopt the bylaw passed by the Association to reduce the vesting requirement.


NOW, THEREFORE THE CITY OF FARIBAULT RESOLVES:


Section 1. That the attached amendment to the Faribault Fire Relief Association regarding reducing vesting requirements be adopted according to M.S.A 423A.

Section 2. That the attached bylaw is not effective until a certified copy of it and the municipal approval has been filed with the executive director of the legislative commission on pensions and retirement, the state auditor, and the secretary of state.


