ORDINANCE NO. 1988-1

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF BROWNSDALE TO INCLUDE CERTAIN UNINCORPORATED TERRITORY WHICH ABUTS THE CITY OF BROWNSDALE IN MOWER COUNTY, MINNESOTA

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated City or borough; and

WHEREAS, this territory abuts the corporate limits of the City of Brownsdale, a municipal corporation under the laws of the State of Minnesota, on one side and petitioners desire to build dwellings on said property and desire to obtain City utilities; THE COMMON COUNCIL OF THE CITY OF BROWNSDALE DO ORDAIN:

Section 1. Territory Annexed. The corporate limits of the City of Brownsdale, Minnesota, are hereby extended to include the platted territory described as follows, which territory now abuts the corporate limits of the City of Brownsdale:

The West 120 feet of the East 380 feet of the North 15 rods, of the South Half of the Southwest Quarter of the Northeast Quarter of Section 9, Township 103 North, Range 17 West, Mower County, Minnesota.

Section 2. Filing. The City Clerk is directed to file certified copies of this ordinance with the Minnesota Municipal Board, Red Rock Township Clerk, County Auditor, County Recorder and Secretary of State.

Section 3. Effective Date of Annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2, and approval by the Minnesota Municipal Board.
