ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Rochester and the the Town of Cascade and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of Rochester and the Town of Cascade indicating their desire that certain property be annexed to the City of Rochester pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on June 5, 1989, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Rochester, Minnesota, the same as if it had originally been made a part thereof:

That part of the Southeast Quarter of Section 8, Township 107 North, Range 14 West, Olmsted County, Minnesota, described as follows:

Commencing at the southeast corner of the Southeast Quarter of said Section 8; thence West, assumed bearing, along the south line 1316.33 feet to the southeast corner of the Southwest Quarter of said Southeast Quarter; thence continue West, along said south line, 590.00 feet for the point of beginning; thence North 01 degree 14 minutes 00 seconds East, 590.64 feet; thence West, 731.81 feet; thence South, 590.50 feet to the south line of said Southeast Quarter; thence East, along said south line, 719.10 feet to the point of beginning.

Containing 9.83 acres more or less.

IT IS FURTHER ORDERED: That the effective date of this order is June 5, 1989.
