REORGANIZATION ORDER NO. 157

Pursuant to Minnesota Statutes 1988, Section 16B.37, the following administrative reorganization is made with the prior approval of the Governor.

In order to improve efficiency, avoid duplication in the operation of state government and carry out the provisions of Minnesota Laws 1989, Chapter 334, the duties of the Minnesota Racing Commission are transferred to the Department of Gambling, Division of Pari-mutuel Racing.

Consistent with this transfer of duties, the following positions and their incumbents, with all accrued benefits, are transferred from the Minnesota Racing Commission to the Department of Gaming, Division of Pari-mutuel Racing:

One additional general fund and (.5) special revenue fund positions authorized by Minnesota Laws 1989, Chapter 269, Section 15, but not yet established, shall be transferred from the Minnesota Racing Commission to the Department of Gaming, Division of Pari-mutuel Racing.

Nothing in this order shall be construed as abrogating or modifying any rights now enjoyed by affected employees under the managerial or commissioner's plan under Minnesota Statutes 1988, section 43A.18 or the terms of an agreement between an exclusive representative of public employees and the state or one of its appointing authorities.

The general fund complement of the Minnesota Racing Commission as provided by Minnesota Laws 1989, Chapter 269, Section 15 is decreased by 8 positions; the special revenue fund complement of the Minnesota Racing Commission as provided by Minnesota Laws 1989, Chapter 269, Section 15 is decreased by 1.5 positions. The general fund and special revenue complements of the Department of Gaming as provided by Minnesota Laws 1989, Chapter 334 are increased accordingly.

The Minnesota Racing Commission shall give to the Department of Gaming all contracts, books, maps, plans, papers, records, supplies, and equipment relating to the transferred duties.

Rulemaking authority for the transferred duties is transferred to the Department of Gaming. All rules adopted by the Minnesota Racing Commission pursuant to these duties remain in effect and shall be enforced until amended or repealed in accordance with law by the Department of Gaming.


Any proceeding, court action, prosecution, or other business or matter pending on the effective date of the transfer may be conducted and completed by the Department of Gaming in the same manner under the same terms and conditions, and with the same effect, as though it involved or were commenced and conducted or completed prior to the transfer by the Minnesota Racing Commission.

The Department of Gaming is the legal successor in all respects of the Minnesota Racing Commission with regard to the transferred duties. The bonds, resolutions, contracts, and liabilities of the Minnesota Racing Commission become the bonds, resolutions, contracts, and liabilities of the Department of Gaming.


The Commissioner of Finance shall make the necessary financial determinations in accordance with Minnesota Statutes 1988, Section 16B.37, Subdivision 3.


