BE IT RESOLVED that the County Board of Commissioners of Carlton
County does hereby find as follows:

That a petition has been presented to the Board to organize
Congressional Township 48 North, Range 20 West as the Town of Eagle,

That upon a report from the County Auditor/Treasurer as to the
signatures contained in said petition, the Board found that said
petition contained a sufficient number of valid signatures to require
an election as required by law,

That an election was held on June 7, 1989, whereby Eagle Township
residents voted on the question of the reorganization of the Town of
Eagle as follows: Yes - 118, No - 25,

That said Town is hereby organized and the name thereof shall be the
Town of Eagle,

That the boundaries of said Town shall include all of the property
located in Congressional Township Forty-eight (48) North, Range
Twenty (20) West,

That the first Town meeting for said Town of Eagle shall be held on
June 30, 1989, at 7:00 p.m., at the Cromwell High School, and,

That the County Auditor/Treasurer shall post notice of said meeting
as provided by law and shall send a report of the organization of
said Township to the various State Agencies as required by law.

resolution was adopted.


