





ORDINANCE NO. 231
AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF
CAMBRIDGE TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY
SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated City or borough; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City and is deemed to be urban or suburban in character;

THE CITY COUNCIL OF CAMBRIDGE ORDAINS:

Section 1. Territory annexed. The corporate limits of the City of Cambridge, Minnesota, are hereby extended to include the unplatted territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the City limits, described as follows:

All that part of the South one-half ($S\frac{1}{2}$) of Section Thirty-two (32), Township Thirty-six (36), Range Twenty-three (23), lying and being West of the West right of way line of State Trunk Highway No. 65 and East of the thread of the Rum River; which has not been previously annexed to the City of Cambridge.


Section 2. Filing. The City Clerk-Administrator is directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor of Isanti County, the Town Clerk of Isanti Township, the Town Clerk of Cambridge Township and the Minnesota Municipal Board.

Section 3. Population. The population of the annexed territory is 306.


Section 4. Effective date of annexation. This Ordinance takes effect upon passage and publication and the filing of certified copies

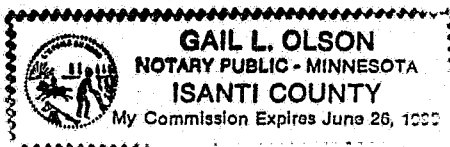
