WHEREAS, a petition for the annexation of certain land to the City of Sartell was filed with the Minnesota Municipal Board on February 15, 1989; and

WHEREAS, an objection by Le Sauk Township to said petition was received on March 10, 1989; and

WHEREAS, a hearing was convened on said petition for the annexation of certain land to the City of Sartell on June 29, 1989 and continued; and

WHEREAS, said hearing was continued to allow for discussions for orderly annexation between the Town of Le Sauk and the City of Sartell; and

WHEREAS, the City of Sartell and the Town of Le Sauk have executed an orderly annexation agreement which contains the property described in said petition; and

WHEREAS, the property owners of said land have requested that the board allow the withdrawal of said petition;

IT IS HEREBY ORDERED: That the above-entitled petition is withdrawn

and the Minnesota Municipal Board file on said petition is hereby closed without prejudice. The property description in said petition is described as follows:

That part of the South Half of Southeast Quarter of Section 17 and that part of the Northwest Quarter of the Northeast Quarter of Section 20 all in Township 125 North, Range 28 West of the 5th Principle Meridian, LeSauk Township, Stearns County, Minnesota, described as follows:

Beginning at the intersection of the center line of Pinecone Road with the south line of said South Half of the Southeast Quarter; thence northeasterly, along the center line of said Pinecone Road, a distance of 100.00 feet; thence northwesterly, at a right angle, along the southerly line of that certain tract of land described in Book 452 of Deeds on Page 701, according to the files of the Stearns County Recorder, a distance of 285.00 feet; thence southwesterly, at a right angle to a point of the northerly line of that certain tract of land described in Book 444 of Deeds on page 485, according to the files of said Stearns County Recorder; thence easterly, along said northerly line to its intersection with the east line of said Northwest Quarter of the Northeast Quarter of Section 20; thence northerly, along said east line to the northeast corner of said Northwest Quarter of the Northeast Quarter; thence easterly, along the south line of said South Half of the Southeast Quarter to the point of beginning.

Containing 2.60 acres, more or less
