You will please take notice, that the undersigned, will, within 30 days, file an application in the General Land Office, at Washington, D. C. for the survey of those certain six Unsurveyed Islands located in Basswood Lake, Lake County, Minnesota, more particularly described as follows, to-wit:

An Unsurveyed Island located in the Northeastern portion of Section 1, Township 64 North, Range 11 West, 4th P.M., lying South 80° East 750 feet from M.C. No. 42 on N.E. Corner of Lot 1 of said Section, containing approximately 2.10 acres.

An Unsurveyed Island located in the central Eastern portion of Section 1, Township 64 North, Range 11 West, 4th P.M., lying South 38° West 1100 feet from M.C. No. 39 on S.E. Corner of Lot 12 of said Section, containing approximately 1.40 acres.

An Unsurveyed Island located in the Northeastern portion of Section 2, Township 64 North, Range 11 West, 4th P.M., lying North 44° West 800 feet from M.C. No. 44 on N. E. Corner of Lot 5 of said Section, containing approximately 8.00 acres.

An Unsurveyed Island located in the S.W. Portion of NE $\frac{1}{2}$ of SE $\frac{1}{2}$ of Sec. 11, Twp. 64 North, R. 11 West, 4th P.M., lying North 63° West 1300 feet from M.C. No. 70 on N.E. Corner of Lot 6 of said Section, containing approximately 1.40 acres.

An Unsurveyed Island located in the Southern portion of NE $\frac{1}{2}$ of NW $\frac{1}{4}$ of Sec. 12, Twp. 64 North, R. 11 West, 4th P.M., lying North 53° East 2000 feet from M.C. No. 72 on N.W. Corner of Lot 7 of said Section, containing approximately 1.70 acres.

An Unsurveyed Island located in the NE $\frac{1}{2}$ of SW $\frac{1}{2}$ of Sec. 12, Twp. 64 North, R. 11 West, 4th P.M., lying North 65° East 1450 feet from M. C. No. 71 on S.W. Corner of Lot 7 of said Section, containing approximately 1.70 acres.

You are allowed thirty (30) days from the receipt of this Notice, within which to file in said General Land Office, any papers you may wish to submit, tending to show cause, if any there be, why the said Islands should not be surveyed and disposed of as public land of the United States.
