REORGANIZATION ORDER NO. 159

Pursuant to Minnesota Statutes 1988, Section 16B.37, the following administrative reorganization is made with the prior approval of the Governor.

In order to improve efficiency and avoid duplication in the operation of state government, the Department of Administration's duties for tax data entry are transferred to the Department of Revenue.

Consistent with this transfer of duties, the following positions and their incumbents, with all accrued benefits, are transferred from the Department of Administration to the Department of Revenue:

In addition, forty-one seasonal employees as listed in Appendix A are transferred from the Department of Administration to the Department of Revenue.

Nothing in this order shall be construed as abrogating or modifying any rights now enjoyed by affected employees under the managerial or commissioner's plan under Minnesota Statutes 1988, Section 43A.18 or the terms of an agreement between an exclusive representative of public employees and the state or one of its appointing authorities.

The revolving fund complement of the Department of Administration as provided by Laws 1989, Chapter 335, Article 1, Section 15, subdivision 1 is decreased by nine positions; the complement of the Department of Revenue as provided by Laws 1989, Chapter 335, Article 1, Section 19, is increased by nine positions.

The Department of Administration shall give to the Department of Revenue all contracts, books, maps, plans, papers, and records relating to the transferred activities.


The Department of Revenue is the legal successor in all respects of the Department of Administration in regard to the transferred duties. The contracts and liabilities of the Department of Administration become the contracts and liabilities of the Department of Revenue.

Any proceeding, court action, prosecution, or other business or matter pending on the effective date of the transfer may be conducted and completed by the Department of Revenue in the same manner under the same terms and conditions, and with the same effect, as though it involved or were commenced and conducted or completed prior to the transfer by the Department of Administration.


No funds are transferred.


