**ORDER** 

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Moorhead and the Town of Oakport and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of Moorhead indicating their desire that certain property be annexed to the City of Moorhead pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on September 5, 1989, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Moorhead, Minnesota, the same as if it had originally been made a part thereof:

<u>Parcel 21</u>: Jerry A. Keogh and Vera Jean Keogh (Jerry's Bar - One acre in the Southwest Corner of the Southeast Quarter of the Southeast Quarter (SE 1/4 Se 1/4), in

Section Thirty-Two (32), Township One Hundred Forty (140), Range Forty-eight (48), Clay County, Minnesota, described as follows: Beginning at the east side of the state road line in the Southwest Corner, extending 20 rods (330 feet) north along said state roads, thence east 8 rods (132 feet), thence 20 rods (330 feet) to the South Section Line in the center of the road, thence west 8 rods (132 feet) to the place of beginning. Also known as auditors outlot 32-E.

IT IS FURTHER ORDERED: That the mill levy of the City of Moorhead on the property herein ordered annexed shall be increased in substantially equal proportions over a period of six years to equality with the mill levy of the property already within the city.

IT IS FURTHER ORDERED: That the effective date of this order is September 5, 1989.
