

ORDINANCE NO. 352

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF STAPLES

The City Council of the City of Staples does ordain as follows:

Section 1. A petition has been filed with the governing body of the City of Staples, Minnesota by Dale R. Adams and Susan Kay Adams, as the owners of the following described real estate for the purpose of having such real estate included within the City limits of the City of Staples, Minnesota:

- Section 2. The above described real estate is unplatted and consists of approximately two acres and the above petitioners are the sole owners of said property.
- Section 3. Notice of the filing of the Petition has been filed with the Town Board of Thomastown Township, the Wadena County Board of Commissioners, the Minnesota Municipal Board and the City of Staples and no objections to the Petition have been received.
- Section 4. All fees required to be paid by the Petitioners have been duly paid.
- Section 5. The City Council hereby determines that the annexation will be to the best interests of the City of Staples, Minnesota and of the territory affected; the real estate described herein abuts upon the City and is so conditioned as properly to be subjected to City government.
- Section 6. Therefore, the City of Staples, Minnesota hereby ordains and declares that the property hereinbefore described be, and the same is, hereby annexed to, and included in, the City of Staples, Minnesota, as effectually as if it had originally been a part thereof.

Section 7. This ordinance shall be final and take effect and be in force from and after filing a certified copy thereof with the Minnesota Municipal Commission, Town Clerk of Thomastown Township, the Wadena County Auditor, and the Minnesota Secretary of State.


