



AGREEMENT BETWEEN THE CITY OF AUSTIN)
AND THE TOWN OF AUSTIN PURSUANT TO)
MINNESOTA STATUTES 414.0325)

ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Austin and the Town of Austin and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of Austin indicating their desire that certain property be annexed to the City of Austin pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on October 3, 1989, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Austin, Minnesota, the same as if it had originally been made a part thereof:

A part of Lot 3, Block 2, Austin Homesteads described as follows: Commencing at a point in the west line of said Lot 3 that is 300 feet south of the northwest corner of said Lot 3; thence east parallel with the north line of said Lot 3 a

distance of 108 feet to the place of beginning; thence north parallel with the west line of said Lot 3 a distance of 100 feet; thence east parallel with the north line of said Lot 3 to the westerly edge of 22nd Street S.W.; thence in a southwesterly direction along the westerly edge of 22nd Street S.W. to a point on the westerly edge of 22nd Street S.W. that is 300 feet south of the north line of said Lot 3; thence west parallel to the north line of said Lot 3 to the place of beginning, Mower County, Minnesota. 0.68 Acres

and

Lot 1, Block 2, Austin Homesteads, Mower County, Minnesota, except the west 120.25 feet of the north 220 feet. 2.56 Acres

IT IS FURTHER ORDERED: That the effective date of this order is October 3, 1989.
