Dear Ms. Lundy:

I enclose and send to you the annexation ordinance, Ordinance No. 84 adopted by the City Council of Karlstad, Minnesota, in accordance with its city ordinances. The City understands that this ordinance does not take full effect until it has been presented to and acted upon favorably by the Minnesota Municipal Board.

As shown by the text of Ordinance No. 84 enclosed herewith the land to be annexed to become part of the City of Karlstad is completely surrounded by city property.

The property is located in Deerwood Township, Kittson County, Minnesota, and by a copy of this letter I am sending this ordinance to the Deerwood Township, the Kittson County Auditor, and the Secretary of State.

The property as described in Ordinance No. 84 enclosed comprises 2.01 acres, more or less. As you can see the property is a 350' x 250' rectangular shape.

In accordance with telephone directions given to me I am enclosing our firm check in the sum of \$100.00 from our office account. I understand that the filing fee charged for annexation is \$5.00 per acre but that a minimum charge for filing is \$100.00.

AN ORDINANCE TO ANNEX LANDS

ORDINANCE NO. 84

The City Council of Karlstad, Minnesota, does hereby ordain and pass the following ordinance in accordance with M.S.A. §414.033:

WITNESSETH:

RECITALS

WHEREAS, the City of Karlstad has within its incorporated city limits a rectangular piece of property which is completely surrounded by land within the municipal limits of the City of Karlstad; and

WHEREAS, the property which is completely surrounded is property which the City Council deems to be urban or suburban in character and nature; and

WHEREAS, the City of Karlstad deems it necessary and desirable to extend and annex that property which is completely surrounded;

NOW, THEREFORE, the following ordinance is hereby adopted by the City Council of the City of Karlstad:

Section 1. Property to be Annexed by Ordinance. The following real property which is land completely surrounded by other land now within the municipal limits of the City of Karlstad, is hereby declared annexed to the City of Karlstad:

That parcel located within the Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section Twenty-four (24), Township One Hundred Fifty-nine (159) North, Range Forty-six (46) West described as follows: Beginning at the northeast corner of the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 24, thence due South a distance of 500 feet to a point which is the POINT OF BEGINNING, thence due West a distance of 250 feet, thence due South a distance of 350 feet, thence due East a distance of 250 feet, thence due North a distance of 350 feet to the POINT OF BEGINNING.

Section 2. The City Clerk is hereby directed to publish notice of this ordinance in the official paper for the City of Karlstad, which official paper is the North Star News published in Karlstad, Minnesota.

Section 3. Effective Date. This ordinance shall become effective when published as required by law, which date of publication shall be set forth below by the City Clerk for the City of Karlstad.


