



The Minnesota Municipal Board has now processed and approved the above ordinance in accordance with Minnesota Statutes, Chapter 414, and the Rules of Procedure.



ORDINANCE ANNEXING PROPERTY TO THE  
CORPORATE LIMITS OF THE CITY OF MANKATO

WHEREAS, certain property described below is not presently included in the corporate limits of any incorporated city, village, or borough; and

WHEREAS, pursuant to Minnesota Statutes 414.033, Subd. 5, the owners of said described property, have petitioned the City of Mankato for annexation of such property; and

WHEREAS, the property is located adjacent to existing City boundaries and can be served with public utilities; and

WHEREAS, the said described property is platted and does not exceed 200 acres in area; and

WHEREAS, the acreage of such area is three (3) acres; and

WHEREAS, the population of the area to be annexed is four (4); and

WHEREAS, the reason for the request of the annexation is to obtain City water and sewer services; and

WHEREAS, the Council of the City of Mankato finds that the property is urban in character and objection to the annexation has been withdrawn by the Mankato Township Board of Supervisors.

NOW, THEREFORE, the Council of the City of Mankato hereby ordains that the corporate limits of the City of Mankato are hereby extended to include the land described as follows, and the same is hereby annexed to an included within the City of Mankato as effectively as if it had been a part thereof:

Lot 11, Subdivision of Lots 3, 4, and 5, of Kranz's Subdivision, except Tract B of Registered Land Survey No. 73, Blue Earth County.

And

Lot 12 of the Subdivision of Lots 3, 4, and 5 of Kranz's Subdivision, according to the plat thereof on file and of record in the office of the County Recorder in and for Blue Earth County, Minnesota, except Tract A of Registered Land Survey No. 73.

The City Clerk is hereby directed to file copies of this ordinance with the Minnesota Municipal Board, the Blue Earth County Auditor, and the Mankato Town Board.

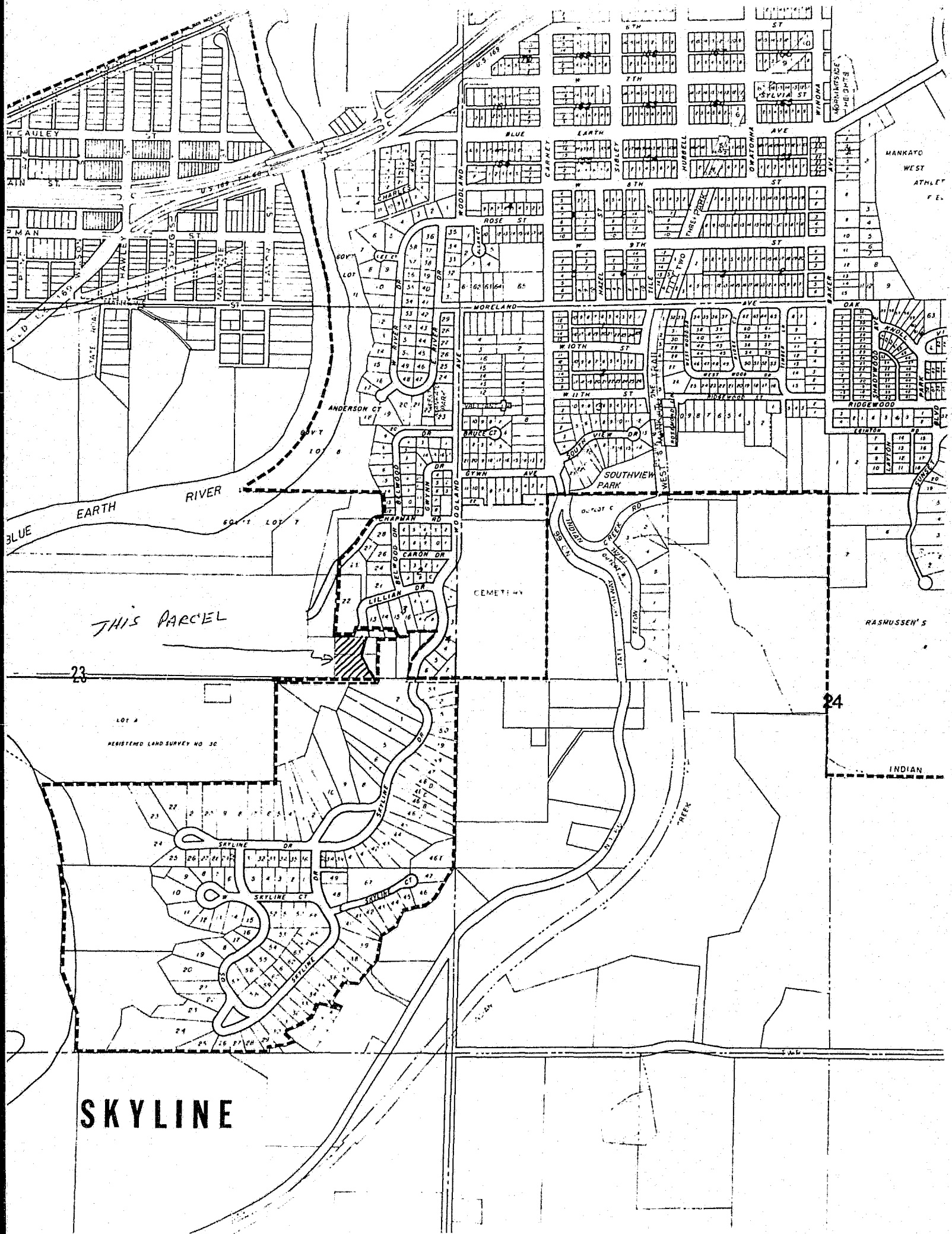
This ordinance shall take effect thirty (30) days after its passage, due publication thereof, and approval by the Minnesota Municipal Board.
