## ORDINANCE NO. 89-11

An Ordinance Annexing Certain Unincorporated Property Abutting the City of Moorhead at the Easterly Boundary Thereof Consisting of 35 Acres, a.k.a. Stuart Ystebo Property, Trunk Highway 10 Right-of-Way

WHEREAS, certain petitions requesting annexation of property hereinafter described were duly presented to the City Council of the City of Moorhead; and

WHEREAS, the quantity of the property described within the petitions is approximately 35 acres of unincorporated land; and

WHEREAS, the petitions were signed by all of the property owners thereof; and

WHEREAS, the property described in the petitions is bordered on its westerly and northerly sides by the City of Moorhead; and

WHEREAS, the Moorhead Planning Commission has favorably recommended to the City Council that said property be annexed by the City of Moorhead; and

WHEREAS, the City Council finds that the property proposed for annexation is now or is about to become urban in character, and annexation of said property is required to protect the public health, safety and welfare and that annexation would be in the best interest of said property proposed for annexation.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Moorhead as follows:

Section 1. That corporate limits of the City of Moorhead are hereby extended to include the following unincorporated and unplatted land:

Parcel A -- Stuart Ystebo Property: A parcel of land located in the Northwest Quarter of Section 10, Township 139 North, Range 48 West of the Fifth Principal Meridian, and more fully described as follows:

Commencing at the Northwest Corner of said Section 10, thence South 0 degrees 17 minutes East a distance of

90.00 feet; thence North 89 degrees 17 minutes East a distance of 69.8 feet to the point of beginning; thence along the south right-of-way line of U.S. Highway No. 10 to the Northwest Corner of Lot 7 in Block 7, Gullings Subdivision; thence south along the west side of Lots 7 and 18 in Block 7, Gullings Subdivision to the Southwest Corner of Lot 18; thence North 89 degrees 17 minutes East a distance of 150.00 feet to the Southeast Corner of Block 7, Gullings Subdivision; thence South 0 degrees 40 minutes East parallel with the north-south quarter line of said Section 10 to the north right-of-way line of Northern Pacific Railroad; thence westerly along the north right-of-way line of Northern Pacific Railroad to a point 69.8 feet east of the west section line of said Section 10; thence North 0 degrees 17 minutes West parallel with the said section line to the point of beginning.

## Parcel 2 -- Trunk Highway 10 Right-of-Way:

A strip of land being the existing Right-of-Way of U.S. Highway 10, more particularly described as follows:

Beginning at the Northwest Corner of Section 10, Range 48 West, Township 139 North of the fifth principal meridian, Clay County, Minnesota; thence easterly to the north Quarter Corner of Section 10, with the north line of said Right-of-Way being the south boundary of Eastgate First Addition and replat of Eastgate Second Addition; and with the south line of said Right-of-Way being the north boundary line of Gulling's Subdivision, together with the widened Right-of-Way within Gulling's Subdivision.

be and the same is hereby annexed to and included within the City pursuant to Minnesota Statute 414.031 as effectively as if it had originally been a part thereof.

Section 2. The City Clerk of the City of Moorhead is hereby directed to file with the Minnesota Municipal Board, the Township of Moorhead, the Clay County Auditor, and the Secretary of State, certified copies of this ordinance herein.

Section 3. This ordinance shall take effect on the date said ordinance is approved by the Minnesota Municipal Board, but in no event shall this ordinance take effect earlier than thirty (30) days after publication in accordance with the Moorhead City Charter.
