You will please take notice, that the undersigned, will, within 30 days, file an application in the General Land Office, at Washington, D. C., for the survey of those certain five Unsurveyed Islands located in Basswood Lake, Lake County, Minnesota, more particularly described as follows, to-wit:

An Unsurveyed Island located in the Southern portion of the NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Sec. 13, Twp. 64 North, Range 11 West, 4th P.M., lying North 65° East 600 feet from M. C. No. 18 on N.W. Corner of Lot 3 of said Section, containing approximately 8.00 acres.

An Unsurveyed Island located in the Southern portion of the SW $\frac{1}{4}$ of NE $\frac{1}{4}$ of Sec. 14, Twp. 64 North, Range 11 West, 4th P.M., lying due south 2200 feet from M.C. No. 34 on N.E. Corner of Lot 1 of said Section, containing approximately 1.40 acres.

An Unsurveyed Island located in the Northern portion of the SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Sec. 14, Twp. 64 N., R. 11 W., 4th P.M., lying North 51° East 1550 feet from M.C. No. 17 on S.W. Corner of Lot 6 of said Section, containing approximately 0.30 acre.

An Unsurveyed Island located in the Northern portion of the SE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Sec. 14, Twp. 64 N., R. 11 W., 4th P.M., lying North 6° West 1150 feet from M. C. No. 17 on S.W. Corner of Lot 6 of said Section, containing approximately 3.00 acres.

An Unsurveyed Island located in the Northern portion of the NE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Sec. 22, Twp. 64 N., R. 11 W., 4th P.M., lying North 20° West 1200 feet from M. C. No. 16 on N.E. Corner of Lot 5 of said Section, containing approximately 1.60 acres.

You are allowed thirty (30) days from the receipt of this Notice, within which to file in said General Land Office, any papers you may wish to submit, tending to show cause, if any there be, why the said Islands should not be surveyed and disposed of as public land of the United States.
