

ORDINANCE—CHAPTER LXVIII

An Ordinance Amending Certain Lots and Blocks to the Village of Montevideo.

The village council of the village of Montevideo do hereby enact as follows:

Section 1. That the following described lots and blocks and parcels of land, to-wit: three parts of lots 6, 7, 8, 9, and 10, in block 1, and lots 7, 8, 9, 10, 11 and 12, in block 2, and lots 7, 8, 9, 10, 11 and 12, in block 3, and lots 7, 8, 9, 10, 11 and 12, in block 4, of Meyer's First Addition to Montevideo, which tract of land adjoining the east line of section 18, in township 107 of range 40, and which lots and upon said village of Montevideo, do and the same are hereby annexed to such village and shall become part of such village as if they had been originally a part thereof.

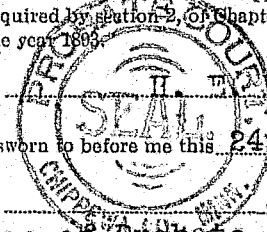
printed and published in said newspaper on Friday the **27th**

That during all the time aforesaid said newspaper was a collection of general and local news, comments and miscellaneous literary items, and was regularly issued and published on Friday of each week from a known office of publication, said office being equipped with the necessary material and skilled workmen for producing the same, and has consisted of not less than four pages of more than five columns to the page, each column not less than seventeen and three-fourths inches in length, and never made up wholly of patents, plates and advertisements, or either or any of them, and has not been substantially a duplicate of any other newspaper, and has been regularly delivered each week to more than two hundred and forty paid subscribers, and that said newspaper, composed and consisting as above set forth, was printed and published in the English language weekly, and generally circulated in Chippewa County for more than one year next preceeding the date of the first publication of said notice: That the publisher of said newspaper on the 13th day of June, 1893, filed with the auditor of said Chippewa County an affidavit setting forth the facts required by section 2, of Chapter 33, of the laws of the state of Minnesota for the year 1893.
