

ORDINANCE NO. 25

Ordinance Extending the Boundaries of the Village of Savage, Minnesota.

The village council of the Village of Savage, Minnesota, do ordain as follows:

Section 1. That in compliance with the petition on file of all of the owners so to do, the boundaries of the Village of Savage, Scott County, Minnesota, are hereby extended so as to include the abutting tract of land, which is less in area than 200 acres, described as follows:

All that portion of the following tract of land which lies Easterly and Northerly of the right of way of the Minneapolis, Northfield & Southern Railway Company, described as follows:

All that part of Sections Thirty (30) and Thirty One (31) Township Twenty Seven (27) Range Twenty Four (24), South of the Minnesota River, described as follows:

Beginning at a point on the South bank of the Minnesota River, on a line with the West line of Walnut Street in the plat of Hamilton, according to said plat on file and of record in the office of the Register of Deeds in and for said Scott County, Minnesota, thence Westerly along said River to its intersection with the west line of said Section Thirty (30); thence South along the West line of said Section Thirty (30) and Thirty One (31) to the North line of the Right of way of the Chicago, St. Paul, Minneapolis & Omaha Railway Company, thence East along said Right of way to a point in the center of Main Street in the Plat of Hamilton; thence North to the North line of the alley running through Blocks Thirty Two (32) and Thirty Three (33), of said plat, thence East along the North line of said alley to the center line of Oak Street in said plat, thence East along the North line of said Summer Street Four Hundred Thirty Three (433) feet, to the West line of Walnut Street; thence North on a line with the West line of said Walnut Street to place of beginning.

Section 2. This ordinance shall be in effect from and after its publication in the Prior Lake News, a newspaper published in the County of Scott, wherein said village is situated.

The foregoing ordinance was duly enacted by a majority of all the members of the village council at a Special Meeting of the Village Council of the Village of Savage, Minnesota, duly held on the 29th day of May, 1928.
