WHEREAS, a joint resolution for orderly annexation was adopted by the City of Buffalo and the Town of Buffalo and duly accepted by the Minnesota Municipal Board; and

WHEREAS, an amended resolution was received from the City of Buffalo and the Town of Buffalo indicating their desire that certain property be annexed to the City of Buffalo pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on January 3, 1990, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Buffalo, Minnesota, the same as if it had originally been made a part thereof:

That part of the East Half of the Northwest Quarter of Section 19, Township 120, Range 25, Wright County, Minnesota, described as follows: Beginning at the southeast corner of said East half of the Northwest Quarter; thence S 88° 50′ 45" W assumed bearing, along the south line of said East Half of the Northwest Quarter, a distance of

200.00 feet; thence N 1° 09' 15" W, a distance of 1540.06 feet; thence N 89° 12' 38" E, a distance of 234.09 feet to the east line of the East Half of the Northwest Quarter; thence S 0° 08' 41" W along said east line, a distance of 1538.96 feet to the point of beginning. Containing 7.68 acres and subject to easements of record.
