



WHEREAS, a joint resolution for orderly annexation was adopted by the City of St. Cloud and the Town of Haven and duly accepted by the Minnesota Municipal Board; and

WHEREAS, said joint resolution requested that certain property be annexed to the City of St. Cloud pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on January 3, 1990, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of St. Cloud, Minnesota, the same as if it had originally been made a part thereof:


Beginning at the Southwest corner of the Northwest quarter (NW 1/4), Section 6, Township 35 North, Range 30 West; thence Northerly along the West line of said Northwest Quarter (NW 1/4) to the Northerly right-of-way line of Lincoln Avenue SE; thence Southeasterly along the Northerly right-of-way line of Lincoln Avenue SE to the Westerly right-of-way line of T.H. 10; thence Southeasterly along the Westerly

right-of-way line of T.H. 10 to the South line of said Northwest Quarter (NW 1/4); thence Westerly along the South line of said Northwest Quarter (NW 1/4) to the point of beginning.

IT IS FURTHER ORDERED: That the effective date of this order is January 3, 1990.



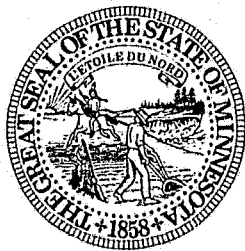
