AND THE TOWN OF ST. CLOUD PURSUANT TO )
MINNESOTA STATUTES 414.0325 )

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Waite Park and the Town of St. Cloud and duly accepted by the Minnesota Municipal Board; and

WHEREAS, said joint resolution requested that certain property be annexed to the City of Waite Park pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on January 3, 1990, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Waite Park, Minnesota, the same as if it had originally been made a part thereof:

Annex County Aid Road #138 along the as traveled centerline with a width of 66.00 feet which extends northeasterly from the northerly right of way line of County Road #75 to 3rd Street North, except that part of said County Road #138 which has been previously annexed, said annexation lies in the Northwest Quarter of Section 17, Township 124 North, Range 28 West, Stearns County, Minnesota. Together with a triangular parcel which is a remnant of the Northeast Quarter of the

Northwest Quarter (NE 1/4 NW 1/4) of said Section 17, said triangular parcel being that part of said NE 1/4 NW 1/4 which lies northwest of the northwesterly right of way line of said County Road #138.

IT IS FURTHER ORDERED: That the effective date of this order is January 3, 1990.
