

AN ORDINANCE ANNEXING CERTAIN LAND INTO THE CORPORATE LIMITS  
OF THE CITY OF WATERTOWN, CARVER COUNTY, MINNESOTA

THE CITY COUNCIL OF THE CITY OF WATERTOWN, CARVER COUNTY,  
MINNESOTA, ORDAINS:

Section 1. Pursuant to Minnesota Statutes Section 414.033, Subd. 5(b), certain land described below is not presently included within the corporate limits of any incorporated municipality, is completely surrounded by land within the present municipal limits of the City of Watertown, is deemed to be urban or suburban in character, is conditioned as properly to be subject to municipal government, and the annexation of said land is in the best interest of the City of Watertown and land to be annexed.


Section 2. THE CORPORATE LIMITS OF THE CITY OF WATERTOWN ARE HEREBY DECLARED EXTENDED TO ENCOMPASS AND INCLUDE ALL THAT CERTAIN LAND DESCRIBED AS FOLLOWS:

Lot One, Block One, and Outlot One, LONGPRE'S  
ADDITION.



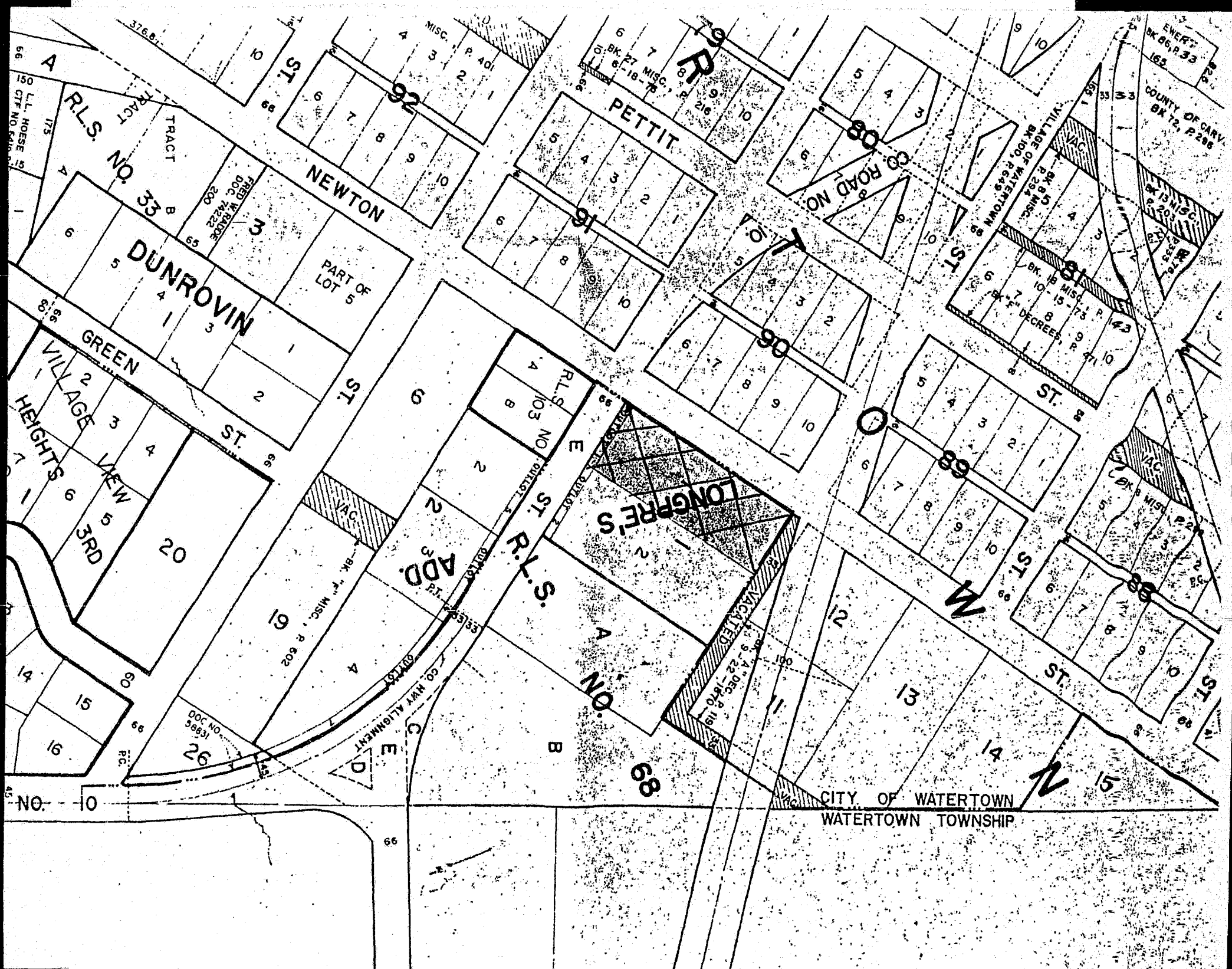
Section 4. This Ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 3 and approval by the Minnesota Municipal Board.




