



WHEREAS, a joint resolution for orderly annexation was adopted by the City of Faribault and the Town of Wells and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of Faribault indicating their desire that certain property be annexed to the City of Faribault pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on February 1, 1990, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Faribault, Minnesota, the same as if it had originally been made a part thereof:

All that part of the Southeast Quarter (SE 1/4) of Section Thirteen (13), Township Twenty-One (21), Range One Hundred Ten (110), lying westerly of westerly line of railroad right-of-way.

IT IS FURTHER ORDERED: That the effective date of this order is February 1, 1990.
