An ordinance extending the corporate limits of the City of Minneota to include certain unincorporated property owned by and abutting upon the limits of the City of Minneota.

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city; and

WHEREAS, this territory abutts upon the corporate limits of the City at the north boundary thereof and is deemed to be urban or suburban in character;

The City Council of the City of Minneota ordains:

Section 1. Territory annexed. The corporate limits of the City of Minneota are hereby extended to include the platted (unplatted) property described as follows: (As Attached).

Section 2. Filing. The property owner is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, the Town Clerk of the affected township and the Minnesota Municipal Board.

Section 3. Effective date of annexation. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 2.
