



WHEREAS, a joint resolution for orderly annexation was adopted by the City of Isanti and the Town of Isanti and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of Isanti indicating their desire that certain property be annexed to the City of Isanti pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on March 1, 1990, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Isanti, Minnesota, the same as if it had originally been made a part thereof:


That part of the NE 1/4 of the NW 1/4 of Section 32, Township 35, Range 23, Isanti County, Minnesota, described as follows: Commencing at the Northwest corner of said NE 1/4 of NW 1/4, thence South along the West line of said NE 1/4 of NW 1/4 to a point 33 feet South of the North line of said NE 1/4 of NW 1/4, as measured at right angles to said North line; thence East and parallel to the North line of

said NE 1/4 of NW 1/4 to the Westerly boundary line of Trunk Highway No. 65 as now located and established in said Township and Range; thence North following the westerly boundary of said Trunk Highway No. 65 to the North line of said NE 1/4 of NW 1/4, thence West along said North line to the point of commencement and there to terminate

IT IS FURTHER ORDERED: That the effective date of this order is March 1, 1990.


