WHEREAS, an amendment to the joint resolution for orderly annexation was adopted by the City of St. James and the Town of St. James and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of St. James indicating their desire that certain property be annexed to the City of St. James pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on February 1, 1990, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of St. James, Minnesota, the same as if it had originally been made a part thereof:

JAMES SQUARE ADDITION

The East 329.42 feet of the West 658.84 feet of the Northwest Quarter

MORNINGSIDE ADDITION



IT IS FURTHER ORDERED: That the effective date of this amended order is February 20, 1990.




