AGREEMMENT BETWEEN THE CITY OF WILLMAR)

AND THEE TOWN OF WILLMAR PURSUANT TO)

MINNESOTA STATUTES 414.0325)

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Willmar and the Town of Willmar and duly accepted by the Minnesota Municipal Board; and

WHEREAS, said joint resolution requested that certain property be an enexed to the City of Willman pursuant to M.S. 414.0325, Subdivision 1; and

WTHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 130 days order the annexation of land pursuant to said subdivision; and

WIHEREAS, on March 1, 1990, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

ICT IS HEREBY ORDERED: That the following described property is hereeby armexed to the City of Willmar, Minnesota, the same as if it had originally been made a part thereof:

No. LI - NW Section 13, Township 119, Range 35

All that part of NW2 of Section 13, Township 119, Range 35, except those parts previously annexed.

No. 22 - SW Section 13, Township 119, Range 35

All that part of SW of Section 13, Township 119, Range 35, lying Northwesterly of the Northwesterly right-of-way line of U.S. Trunk

Highway 71/State Trunk Highway 23 by-pass, except those parts previously annexed.

No. 3 - NE Section 14, Township 119, Range 35

All that part of S1 of NE1 of Section 14, Township 119, Range 35, except those parts previously annexed.

No. 4 - SEl Section 14, Township 119, Range 35

All that part of SE1 of Section 14, Township 119, Range 35 except those parts previously annexed.

No. 5 - NE: Section 23, Township 119, Range 35

All that part of E½ of NE½ of Section 23, Township 119, Range 35 lying Northwesterly of the Northwesterly right-of-way line of U.S. Trunk Highway 71/State Trunk Highway 23 by-pass, except those parts previously annexed.

No. 6 - NW Section 24, Township 119, Range 35

All that part of Government Lot 1 and the N½ of NW½ of Section 24, Township 119, Range 35 lying Northwesterly of the Southeasterly right-of-way line of U.S. Trunk Highway 71/State Trunk Highway 23 by-pass.

TOTAL AREA = 325.35 acres
