WHEREAS, a joint resolution for orderly annexation was adopted by the City of Austin and the Town of Austin and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of Austin indicating their desire that certain property be annexed to the City of Austin pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on May 1, 1990, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Austin, Minnesota, the same as if it had originally been made a part thereof:

Commencing at the southeast corner of Lot 2, Block 3, Plat of Austin Homesteads, Mower County, Minnesota, then westerly on the south line of said Lot 2 213 feet thence northerly on a line parallel to the east line of said Lot 2 a distance of 82.85 feet to the point of beginning thence westerly on a line parallel to the south line of said Lot 2 to the east property line of 21st Street S.W. thence northwesterly along said east property line of 21st Street S.W. to the west line of said Lot 2 thence northerly on said west line to the south property line of

11th Avenue S.W. thence southeasterly along the south property line of 11th Avenue S.W. to a point on a north-south line that is parallel to and 213 feet west of the east line of said Lot 2, Block 3 thence southerly along this northsouth line to the point of beginning. 1.8 Acres

IT IS FURTHER ORDERED: That the effective date of this order is May 1, 1990.
