

## ORDINANCE NUMBER 120-3rd SERIES

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF EAST GRAND FORKS TO INCLUDE CERTAIN UNPLATTED LAND IN GOVERNMENT LOT 3, GOVERNMENT LOT 5, AND THE SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER (SE<sup>1</sup>/<sub>4</sub> SW<sup>1</sup>/<sub>4</sub>) OF SECTION SEVEN (7), TOWNSHIP ONE HUNDRED FIFTY ONE (151) NORTH, RANGE FORTY-NINE (49) WEST OF THE FIFTH PRINCIPAL MERIDIAN, POLK COUNTY, MINNESOTA, NOT EXCEEDING TWO HUNDRED ACRES, WHICH TRACT CONTAINS 6.77 ACRES, MORE OR LESS.

The City Council of the City of East Grand Forks, Minnesota, do ordain:

Section 1. A petition has been filed with the City Council of the City of East Grand Forks, Minnesota, by KLK Investments, a Minnesota Partnership consisting of Kerry L. Knoff, Kurt L. Knoff, and Kim L. Knoff, and Park West Limited, a Corporation, being the owners of the land hereinafter described, to have such land included within the city limits of the City of East Grand Forks; that copies of said petition were filed with the Minnesota Municipal Board, the Town Board of Huntsville Township, and the County of Polk, Minnesota; and that a Waiver of Objections has been received from Huntsville Township.

degrees 07 minutes 39 seconds East a distance of 250.00 feet; thence North 45 degrees 52 minutes 21 seconds West a distance of 400.00 feet; thence North 61 degrees 18 minutes 06 seconds West a distance 202.20 feet to the easterly boundary of Riverview 3rd Addition; thence continuing along said easterly boundary South 13 degrees 16 minutes 08 seconds West a distance of 250.00 feet; thence southeasterly a distance of 70.02 feet along a non-tangential curve concave to the southwest, radius 130.00 feet, chord distance 69.17 feet, chord bearing South 61 degrees 18 minutes 06 seconds East; thence South 45 degrees 52 minutes 21 seconds East a distance of 112.73 feet; thence South 0 degrees 46 minutes 30 seconds East a distance of 66.97; thence South 44 degrees 07 minutes 39 seconds West a distance of 172.57 feet; thence South 45 degrees 52 minutes 21 seconds East a distance of 160.00 feet; thence South 44 degrees 07 minutes 39 seconds West a distance of 40.00 feet; thence southerly a distance of 55.85 feet along a tangential curve concave to the

- a. That the quantity of land embraced within the foregoing description is less than 200 acres.
- b. That the annexation will be to the best interests of the City of East Grand Forks, Minnesota, and of the territory affected.
- c. That the territory and land described as above abuts upon the City of East Grand Forks, Minnesota, is suitably conditioned for municipal government and is about to become urban in character.
- d. That the petition for annexation assigned by all of the owners of the land and real estate hereinabove described.

Section 4. The corporate limits of the City of East Grand Forks, Minnesota, are hereby extended to include the property described in Section 2, and the same is hereby annexed to and included in the City of East Grand Forks, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. The Clerk/Treasurer of the City of East Grand Forks is hereby directed to file certified copies of this Ordinance with the State of Minnesota Municipal Board, the County Auditor of Polk County, the Chairman of the Town Board of Huntsville Township, and the Secretary of State of the State of Minnesota.

Section 6. This Ordinance takes effect upon its passage and publication, and the filing of the certified copy as directed in Section 5, and shall be given the Number <u>120-3rd Series</u>.

ORDINANCE NO. 141

## AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LESTER PRAIRIE TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING ONE ACRE IN AREA ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain Petition for Annexation dated April 2, 1990 requesting annexation of the territory hereinafter described was duly presented to the Council on the <u>9</u> day of <u>April</u>, 1990; and WHEREAS, the quantity of land described within the area described in the petition and bounded as described is less than one acre of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all the owners of said lands; and

WHEREAS, no objections to the annexation have been received from the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and the town board has waived its right to object; and

WHEREAS, no hearing is required by law on the proposed annexation; and

WHEREAS, the land described in the petition abuts upon the City limits at the West boundary thereof.

THE CITY COUNCIL OF LESTER PRAIRIE, MINNESOTA ORDAINS:

<u>Section 1</u>: The City Council hereby determines (1) that the annexation will be to the best interest of the City and the territory affected; (2) that the territory described herein abuts upon the City limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough. <u>Section 2</u>: Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and include within the City as effectually as if it had originally been a part thereof:

That part of the following described tract lying Southerly of the line parallel to and 642 feet South of the south line of Second Avenue:

That part of Lot 31, Auditor's Plat of Section 2, Township 116, Range 27, in the Southwest Quarter of said Section 2, McLeod County, Minnesota described as follows:

Commencing at a point 60.00 feet East and 120.00 feet South of the southeast corner of BASEL'S FIRST ADDITION, according to the recorded plat thereof; thence South, a distance of 260.00 feet to the point of beginning of the tract to be described; thence West, a distance of 60.00 feet to a point 303.85 feet East of the east line of Lot 6, Block 2, of DAMMANN'S FIRST ADDITION according to the recorded plat thereof; thence South on a line parallel to the east line of said DAMMANN'S FIRST ADDITION, a distance of 90.71 feet; thence East, a distance of 60.00 feet; thence North, a distance of 90.71 feet to the point of beginning.

ALSO:

That part of Lot 31, Auditor's Plat of Section 2, Township 116, Range 27 in the Southwest Quarter of said Section 2, McLeod County, Minnesota described as follows:

Beginning at a point 60.00 feet East and 31.5 feet more or less South of the Southeast Corner of BASEL'S FIRST ADDITION according to the recorded plat thereof; also being the southwest corner of Lot 8 of Block 2 of FIRST SOUTHWEST ADDITION according to the recorded plat thereof; thence South to a point 60.00 feet East and 470.71 feet South of said southeast corner of BASEL'S FIRST ADDITION also being 363.85 feet East of the east line of DAMMANN'S FIRST ADDITION according to the recorded plat thereof; thence East on a line parallel to the south line of said FIRST SOUTHWEST ADDITION to a point 135.00 feet West of the southerly extension of the west line of Hickory Street as measured parallel with said south line of FIRST SOUTHWEST ADDITION; thence North on a line parallel to said west line of Hickory Street to said south line of FIRST SOUTHWEST ADDITION; thence West along said south line of FIRST SOUTHWEST ADDITION to the point of beginning.

<u>Section 3</u>: Filing. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Secretary of State, McLeod County Auditor, Bergen Township Clerk and McLeod County Recorder.

<u>Section 4</u>: Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3, and after approval by the Minnesota Municipal Board.
