ORDINANCE XII - Part 4B AN ORDINANCE TO ANNEX TO THE CITY OF WARREN CERTAIN UNPLATTED LANDS

The City Council of the City of Warren, Minnesota, does ordain as follows: 133.25 (201

SECTION 1

That Charles R. Steffan and Margaret L. Steffan are the sole owners of certain real estate located in Marshall County, Minnesota and legally described as follows:

A tract of land in the Northeast Quarter (NE%) of Section Thirty-six (36), Township One Hundred Fifty-five (155) North, Range Forty-eight (48) West described as follows: Beginning at the Northeast corner of Lot 1, Block 1, Sedlacek's Addition to the City of Warren; thence in a northeasterly direction on a 10 degree curve (delta Angle 30°00') for a distance of 300 feet, the tangent of said curve being an extension of the tangent of curve No. 1 of said Sedlacek's Addition; thence in a northwesterly direction, parallel with the north line of said Lot 1 for a distance of 215 feet, more or less, to the center of the channel of the Snake River; thence in a southwesterly direction along said channel to an intersection with the northerly line of said Lot 1 extended Northwesterly; thence in a southeasterly direction along said extended line and along the northerly line of said Lot 1 to the point of beginning.
