

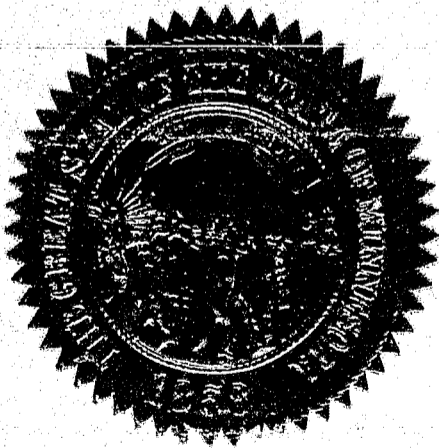





C E R T I F I C A T E
OF THE VOTE OF PRESIDENTIAL ELECTORS
STATE OF MINNESOTA.

We, the undersigned, electors of President and Vice President of the United States of America, for the respective terms beginning on the fourth day of March, in the year of our Lord One Thousand Nine hundred and Twenty-nine, being electors duly and legally elected, appointed and qualified by and for the State of Minnesota, as appears by the annexed list of electors, made, certified and delivered to us by the Governor of the State of Minnesota, having met and convened at the Capitol in the City of St. Paul in the State of Minnesota, in pursuance of the directions of the Legislature of the State of Minnesota, and in conformity with the laws and the constitution of the United States, on the first Wednesday, being the second day of January, A. D. 1929:

WE DO FURTHER CERTIFY, That George P. Gurley, one of the electors duly and legally elected, appointed and qualified failed to appear before 9 o'clock A. M. on such second day of January, A. D. 1929, and being so assembled and organized we proceeded to fill the vacancy caused by said failure to appear and in the presence of the Governor of the State of Minnesota and in pursuance of the directions of the Legislature of the State of Minnesota elected by ballot Mrs. Manley L. Fosseen to fill such vacancy:

DO HEREBY CERTIFY, That, being so assembled and organized, we proceeded to vote by ballot, and balloted first for such President and then for such Vice President, by distinct ballots:
