Upon the stipulation of the attorneys for the contestant and contestee in the above matter, and upon the report of the inspectors herein showing that Harry A. Montgomery, contestant, received 11,189 votes, and Emil S. Youngdahl, contestee, received 11,394 votes, for the office of State Representative from the 35th Legislative District, State of Minnesota, at the general election held November 6, 1928, and upon motion of Frank E. Clinite, attorney for contestant,

IT IS HEREBY ORDERED that Emil S. Youngdahl, contestee, was duly elected to the office of State Representative from the said 35th Legislative District, State of Minnesota, at the general election held November 6, 1928, and is entitled to all the rights and privileges of said office.

IT IS FURTHER ORDERED that the said Emil S. Youngdahl is entitled to a certificate of election, and the Auditor of Hennepin County, Minnesota, is hereby directed to issue and deliver said certificate to him.

IT IS FURTHER ORDERED that the surety bond in the sum of \$250.00 filed herein by contestant be, and the same is hereby, terminated, and the surety thereon released and discharged from any further liability by reason of the execution of said bond.

IT IS FURTHER ORDERED that Harry A. Montgomery, the contestant, pay to the inspectors herein the following costs:
